Re: **Senate Bill 1147 Transportation Finance Passed Transportation Committee with a Unanimous Vote**

As the Board recalls, our Legislative Agenda indicated the County would support any legislation that would increase transportation revenues such would allow for a more rapid road repair and pavement preservation program designed to repair all of the streets and highways in the unincorporated area of Pima County within the next 10 years. Senate Bill 1147 passed unanimously as amended by the Senate Transportation Committee would be a positive step in that direction and was supported by Pima County. This Bill would essentially allow the regional council of governments through the Regional Transportation Authority (RTA) to develop an appropriate plan for transportation investment that would then be approved by both elected officials of the Pima Association of Governments (PAG), the Metropolitan Planning Organization, as well as the RTA. More importantly, the Board would then have the option of placing the funding mechanism, which is an additional half-cent sales tax, before the voters of Pima County. In essence, County voters and taxpayers would decide whether or not to fund transportation investments.

Yesterday, Supervisor Miller's representative to the Transportation Advisory Committee hearing opposed allowing the voters to decide on transportation investment in Pima County.
