We will not be able to attend, as we are traveling out of state July 6-July 22, 2016. We still want to voice our opposition to the rezoning. If the Commission recommends it to the County Board of Supervisors, we think the easement should become a county maintained road, since it is the county that wants the growth to increase their property tax income. The burden should not be put on the land owners who bought their properties when the traffic across their properties was to be minimal...as in an easement, not a road. We would also like to see the rezoned properties be required to have block walls up along the east and north combined property lines, to protect the privacy of the adjoining properties (one of which we own). We have voiced these requirements onto the deaf ears of Brent Davis. But maybe the Commission will do *something* in the neighbors' favor.
