On Thursday, October 18, 2012, the Flowing Wells Neighborhood Association and Community Coalition (FVNACC) will celebrate 17 years of remarkable accomplishments. The festivities coincide with the FVNACC monthly general meeting at 6:00 p.m. at the Ellie Towne Flowing Wells Community Center, 1660 W. Ruthrauff Rd. Dr. Nic Clement, Superintendent of the Flowing Wells School District, will be the featured speaker.

The community center is just one of the projects that has grown from the efforts of local residents who banded together in 1995 to address common concerns about the safety and quality of life in their neighborhood. The Ellie Towne Flowing Wells Community Center, named for the dynamic leader of the coalition, is also the home of a health center and the Flowing Wells Branch Library is located across the street from the community center. Both Flowing Wells District Park and Curtis Park were developed in partnership with Pima County Natural Resources, Parks and Recreation to provide sports opportunities and outdoor enjoyment to local residents.

Sharon Bronson, Pima County Supervisor for District 3, has been a strong ally of FVNACC and has supported their efforts to add valuable amenities to the community. Building close working relationships with other partners including the Flowing Wells Unified School District, social service agencies, faith-based entities, and the local government has resulted in over \$75 million in goods and services for the people that FVNACC serves.
