## Explanation of Charges

### Verizon Wireless' Surcharges

If payment is returned unpaid, you authorized us to collect an additional \$25 fee through EFT from your account.

### FUSC Change

The Federal Universal Service Charge (FUSC) is a carrier charge that is subject to change each calendar quarter based on contribution rates prescribed by the FCC. On April 1, the FUSC changed to 3.98 percent of assessable wireless charges except for separately billed interstate and international telecom charges. The FUSC on these charges changed to 16.6 percent.
