1. If you are a **juvenile** (under 18 years old) you **MUST** appear, with a parent or guardian, before a judge or hearing officer on your court date.
2. If you are an **adult** charged with Criminal Traffic, Criminal, or Petty offense, you **must** appear before a judge at the date and time listed on your ticket.
3. If you are an **adult** charged with ONLY civil traffic offenses you have the three (3) options listed on the reverse.

**BICYCLE SAFETY DIVERSION PROGRAM:** Defendants and juveniles cited for a civil traffic violation(s) while operating a bicycle may qualify for this program. Contact the Ajo Justice Court, (520) 387-7684 **before** your arraignment date to obtain information about this free program and eligibility requirements. You may visit [www.BikePed.pima.gov](http://www.BikePed.pima.gov) for information on the program.

Upon successful completion, all violations may be dismissed.

**OPTION 1: ATTEND DEFENSIVE DRIVING SCHOOL OR BICYCLE SAFETY DIVERSION PROGRAM (civil traffic offenses only)**

If you were cited for one or more civil traffic violation(s) you may attend Defensive Driving School to resolve **one** charge. Eligible charges are noted with an asterisk (\*) on the fine schedule.

**ELIGIBILITY:**

1. You have not attended defensive driving school in Arizona in the past two years.
2. You do **NOT** have a commercial driver's license (CDL).
3. You are at least 18 years old.

If you were cited for 28-701A (accident) and there was serious injury your request for Defensive Driving school must be done in person on your court date.

**ADVANTAGES OF DEFENSIVE DRIVING SCHOOL:**

- A. **No** court appearance for one traffic charge.
- B. The eligible charge will be dismissed and no points will be assessed on your license for that charge.
- C. You will **not** have to pay a court fine for that charge.

**HOW TO ENROLL:** Find a list of schools approved by the Arizona Supreme Court by calling 1-888-334-5565 or visit <http://www.azcourts.gov/drive/ListofCertifiedSchools.aspx>.

Online classes are available for out of state residents. **You must complete the class 7 days before your court date.** On the day of your class you must bring with you:

- a. A copy of your ticket;
- b. Your driver's license; and
- c. A certified cashier's check or money order payable to the school.

**Contact the school for the cost of the course.**

**OPTION 2 – PAY YOUR FINE BY MAIL (CIVIL TRAFFIC OFFENSES ONLY).** Payment must be received prior to the court date indicated on the bottom of your ticket.

**1. Read and Sign the following statement:**

*I hereby waive my right to a trial and enter a plea of responsible to the charges listed on my traffic ticket.*

**2. Determine Payment Amount:** Match each violation (e.g. A.R.S. 28-701) on your complaint to the codes listed on the Fine Schedule, and record in the box below. If you do not pay the fine **and** fees in full, the court will add \$20.00 time payment fee, pursuant to A.R.S. 12-116.

**3. Do not send cash.** Check, money order, or cashier's check payable to **AJO JUSTICE COURT.**

*NOTE: If you plead responsible for Red Light Violations 28-645A3A or 28-647, Motor Vehicle Division (MVD) will require you to attend Traffic Survival School (TSS). However, if you are eligible for Defensive Driving School and complete the class, the violation will be dismissed and MVD will not require you to attend TSS.*

**OPTION 3 -REQUEST A TRIAL DATE by mail (CIVIL TRAFFIC OFFENSES ONLY)**

- a. The court must receive your request **prior to the court date written on your ticket.** You may also appear in person on your court date and request a trial. Trial takes place at a later date.
- b. If you request a trial you give up the option of attending defensive driving school for that violation.
- c. You may voluntarily post a deposit (cashier's check or money order) in the amount of the civil penalty to ensure your license is not suspended should you fail to appear on your scheduled trial date. Do not send cash. Follow payment instruction in Option 2. If the judge rules in your favor at trial, your deposit will be returned to you.

The officer who issued the ticket will be subpoenaed to appear at the trial. You must appear on the date scheduled and be prepared to present evidence and/or examine witnesses before a Judge or Civil Traffic Hearing Officer.

**TO REQUEST TRIAL BY MAIL:**

**1. READ and SIGN the following statement:**

*I plead NOT RESPONSIBLE to the charges listed on my ticket and request the court set a trial/hearing date. I give up my option to attend Defensive Driving School. I understand that my failure to appear at trial may result in a Default Judgment for all civil fines and driver's license suspension.*
