The following clarifications shall be incorporated into **IFB #151635**:

1. **Change** on page 5: **1. INTENT**: as follows:

From: "...This document is intended to establish an "As Required" indefinite delivery/indefinite quantity (IDIQ) "Master" agreement contract to provide Pima County ("County") with such quantities of bread and bakery products as the County may order from time to time by issue of Delivery Order (DO) or Delivery Order Maximo (DOM) pursuant to a resulting executed and effective agreement..."

To: "...This document is intended to establish an "As Required" indefinite delivery/indefinite quantity (IDIQ) "Master" agreement contract to provide Pima County ("County") with such quantities of bread and bakery products as the County may order from time to time by issue of Delivery Order (DO) or Delivery Order Maximo (DOM) pursuant to a resulting executed and effective agreement. **It is the intent of Pima County to award to one vendor...**"

2. **Change** on page 6: **4. PRODUCT OR SERVICE SPECIFICATIONS & SCOPE**: as follows:

From: "...

To: "...

3. **Change** on page 8: **UNIT PRICES (Net 30 day Payment Terms)** as follows:

From: "...All unit prices **shall** be filled in. Failure to do so **shall** be cause for rejection as non-responsive..."

To: "...All unit prices **shall** be filled in. Failure to do so **shall** be cause for rejection as non-responsive. **All line items shall be bid on. Failure to do so shall be cause for rejection as non-responsive...**"

4. **Change** on page 9: **8. DELIVERY**: as follows:

From: "...Supplier guarantees delivery of product or service in less than three (3) calendar days after issue date of order..."

To: "...Supplier guarantees delivery of product or service in less than **five (5) calendar days** after issue date of order..."

5. **CLARIFICATIONS** as follows:

On page 6 of 17 – 4. **PRODUCT OR SERVICE SPECIFICATIONS & SCOPE:**

QUESTION: Do line items 3 and 4 (hot dog buns and hamburger buns) have to be sliced?

ANSWER: *Yes, these items **have to be sliced** when they are delivered to Pima County.*

All other terms and conditions remain the same.
