## PAYMENT/CANCELLATION TERMS

The price for a 6-foot draped table is \$175.00. With electricity, table price is \$200.00 (**we have a limited number of tables with electricity**). Any additional space must be pre-approved and an additional \$100.00 will be added to the registration fee. Tables will be assigned on a first come, first served basis. **The registration fee must be paid in full no later than APRIL 5, 2019 by check or money order** and must accompany this contract. There will be **no refunds after April 5, 2019** for cancellations.

## SET-UP AND REMOVAL TIME

The event will be held from 9:00 A.M. to 2:00 P.M. Exhibitors will be able to set up displays on Friday, April 26, 2019 starting from 7:00 A.M. **There are no other set-up times. Vehicle entrance for unloading/loading is limited and all vendors will need to utilize the military assistance provided. Displays should not exceed 6 foot in width without prior approval.** Your exhibit must be contained within the area provided (this includes all equipment you are bringing). There will be a limited amount of booths available for electricity and all displays must be approved in advance, and will be assigned on a first-come-first served basis. In fairness to attendees, displays **MUST NOT** be taken down before 1:00 P.M. Exhibitors are responsible for removing display material and equipment **immediately** following the Expo at 2:00 P.M. **\* Note: No Wi-Fi connection.**
