American Red Cross Lifeguard Training Classes will be offered by Pima County and YMCA Staff. FEE: \$35.00 payable to Pima County NRPR. Cash, check, money order or credit card (Visa or MasterCard) accepted, please do not send cash in the mail.

There is a pre-requisite swim of at least 300 yards continuously (using breaststroke and freestyle), treading water for 2 minutes without the use of arms, and a 10 pound brick retrieval so please be prepared. **Fee is non-refundable**, but may be transferable to a later review class. Class sizes are limited and are filled on a first come basis. In the event that the pool is closed due to weather or any other unforeseeable circumstance, the class may need to be extended to meet all objectives at the discretion of the head lifeguard instructor.
