



# WSI (Water Safety Instructor) Training Classes

American Red Cross Water Safety Instructor (WSI) Training Classes will be offered by Pima County Staff for current employees. **FEE: \$87.00 payable to Pima County NRPR. Cash, check, money order, or credit card (Visa or MasterCard) accepted, please do not send cash in the mail.** Participants must be at least 16 years old to join the class (**to be employed by Pima County, participants must also have Lifeguard Training and CPR/AED for the Professional Rescuer**). Participants must also be able to demonstrate abilities in front crawl and back crawl, breaststroke, butterfly, sidestroke, and elementary backstroke. Please be prepared as **fees are non-refundable**, but may be transferable to a later class. Class sizes are limited and are filled on a first come basis. In the event that the pool is closed due to weather or any other unforeseeable circumstance the class may need to be extended at the discretion of the head lifeguard instructor.
