SOLICITATION: Pima County is soliciting applications from Agencies qualified, responsible and willing to provide services for the residents of Pima County in compliance with all requirements contained or referenced herein.

GENERAL DESCRIPTION: Community Workforce and Development (CWD) Department mission is to provide resources that strengthen communities and improve the quality of life for residents. The Outside Agency (OA) Program targets economically disadvantaged and other at-risk populations, and specifically, it assures that support is provided to meet basic needs and services in rural areas. Each year, the Pima County Board of Supervisors establishes funding limits for the OA Program. Agencies are funded for one fiscal year, with the potential for a second year of funding.

APPLICATION PROCESS: Agencies must submit a Pre-Application, which will be reviewed by designated staff to determine if the program meets County requirements for funding. Specific documents will be required to be uploaded at that time. Agencies that do not meet the minimum requirements will not be eligible to submit a full Application. Agencies that have their Pre-Application approved will be notified via ZoomGrants.
