II. Approval of Minutes, Sgt. Don Lafreniere, User Committee Co-Chair

Sgt. Lafreniere asks members if there are any suggested changes for the January 13, 2006 joint meeting minutes. Ted Martin moves to accept and approve the minutes. Gary Bynum seconds the motion. Motion is unanimously carried.

III. Consultant Services, CTA Communications Capt. Paul Wilson, Pima County Sheriff's Department

Captain Wilson explains that Technical and User Committee members should have received copies of the introductory letters regarding the needs assessment process and appropriate survey instruments. CTA Communications will be in town beginning Wednesday, February 22, 2006, to begin the needs assessment process. Pima County Office of Emergency Management has a scheduled appointment to review current EOC operations.

On Thursday, February 23, 2006, CTA Communications will attend the Executive Management Committee meeting for their project initialization presentation where they will introduce their company to the committee and explain the work they will be performing for Pima County. Information will be given on how their work will be conducted. Needs assessment interviews will begin directly following the meeting. Federal and State agencies wanting interoperability will have the opportunity to participate in the assessment. In addition, CTA Communications will have four (4) separate needs assessment teams in town looking at various communications and dispatching facilities. Two (2) teams will assess the radio needs and two (2) teams will assess dispatch facilities. Captain Wilson explains that he grouped individual fire districts together into one meeting where several districts are dispatched by a particular agency.

Separate assessment teams will visit various communications centers to meet with staff members, assess PSAP operations, discuss how each center dispatches information, and to assess each facility. CTA Communications will document what they see; console set-up, software, and equipment. Beginning March 13, 2006, CTA Communications will return to assess Pima County's existing antenna sites. Sites selected are expected to be the most useful for this project. Additional details will be given at the Executive Management Committee meeting on February 23, 2006.

Captain Wilson asks committee members who had a conflict with their scheduled appointments with CTA Communications to raise their hands and he would address those issues. No response was noted. Survey handouts were available at the meeting if members did not already receive them.

VIII. Workgroups, Capt. Paul Wilson, Pima County Sheriff's Department

Captain Wilson explains that all committee members should have received a memorandum attached to the Agenda Addendum with regards to workgroups. He adds that both committees have grown to a size that makes work production difficult. The creation of individual workgroups would allow members with specific expertise to come together and give ideas and recommendations to a larger group. The idea is to minimize the size of the workgroups to create flexibility and increase productivity for final action. Captain Wilson stresses the idea is not to take away from Committee responsibility, rather add a proactive approach to an end result. Smaller groups would allow flexibility on individual work.

Captain Wilson proposes creating 2-3 workgroups for each Committee.

User Committee Workgroups

Interoperability & Talk Group Planning Workgroup:

- Recommend methods of system wide interagency and interdisciplinary interoperable communication
- Assist individual agencies with talk group planning
- Responsible for creating an interoperability communications plan for use of the ACU1000 and Gateway solutions
- Transfer the plan to the Technical Committee for consideration of technical solutions to meet the defined user's needs

Communications / EOC Facility Planning Workgroup:

- Responsible for contributing to the planning needs of the communications / EOC facilities (site selection, operation concepts, building design requirements, systems requirements)
- Work in conjunction with Technical Committee workgroups as subject matter crosses boundaries from operational requirements to technical systems design

Technical Committee Workgroups

Radio Frequency Technology Workgroup

- Recommend action on topics related to voice, data, and microwave radio design, technology, and the operations and maintenance of each system

Networking Workgroup

- Recommend action on wired, wireless, and fiber optic network options available to meet requirements of voice, data, and application and storage solutions
- Develop network security policies to meet requirements of ACJIS and the Health Insurance Portability and Accountability Act

Applications Workgroup

- Define application networking and security requirements
- Document specifications required to interface requirements and to promote data sharing among agencies

Captain Wilson explains the need for additional workgroups in the future will grow and dissolve as needs dictate.

Captain Wilson asks the Committees to grant motions allowing himself, as Project Manager, to establish workgroups, as necessary, without prior approval, and to identify who is assigned to each workgroup. Each workgroup must report back to the parent committee with workgroup activity. The second motion includes the recommendation that parent committees meet individually on a revised bimonthly schedule or more frequently as requested by the Chair(s). Joint meetings may continue as required by the Committee Chair(s) or return to individual Committee meetings.

Lt. Sacco asks Captain Wilson to clarify whether the groups have to make quorum to make decisions or do the groups have to report to the parent committee for proposals. Captain Wilson explains that workgroups will make recommendations to the parent committee.

Workgroup Motion

Larry Stevens, User Committee Member, motions to empower Captain Wilson, PCWIN Project Manager, to establish future workgroups as required, and be responsible for reporting workgroup activities to the parent committees. Gary Bynum, User/Technical Committee Member, seconds the motion. Motion is unanimously carried.

Pat Joy, motions for the Technical Committee. Gary Bynum seconds the motion. Motion is unanimously carried.

Bimonthly Schedule Motion

Captain Wilson suggests that the Committees meet bimonthly to allow the workgroups time to meet and gather ideas for future action. Lt. Sacco explains that both committees met together for specific reasons; to find out information on each committee. He adds that although individual workgroups may create new ideas, information may not be shared when committees separate.

Sgt. Lafreniere asks for the Committees to vote on the motion made by Captain Wilson.

Larry Stevens, User Committee Member, motions that the committees may continue meeting jointly/bimonthly or as required by the Committee Chair(s). Dan Morelos, User Committee Member, seconds the motion. Motion carried.

Pat Joy motions for the Technical Committee. John Moffatt seconds the motion. Motion is unanimously carried.
