IV. Business Plan Distribution Captain Paul Wilson, Pima County Sheriff's Department

On November 14, 2007, the Staff Office mailed participating agencies the PCWIN Final Business Plan. The packet includes a cover letter to the agency Chief, which provides an update on the project; a Memorandum of Commitment to affirm each agency's support of the project at a department level; a subscriber equipment survey, which gives each agency the opportunity to update their subscriber numbers for 2009; a Cost Comparison spreadsheet, which outlines reported annual costs an agency is anticipated to pay for legacy systems repair, fixed equipment, and subscriber equipment; the Business Plan Executive Summary; and the Business Plan on CD.

Captain Wilson refers to the Committee for questions. He receives no response.

V. Grant Funding
Captain Paul Wilson, Pima County Sheriff's Department

On behalf of PCWIN, the County submitted five (5) workbook applications for PSIC funding consideration. Arizona received \$17.7M from that \$1B Commerce Department grant. A total of 33 workbooks were submitted, statewide; 20 came from the Southern region.

Two (2) additional workbooks were submitted within Pima County; one (1) from the Northwest Fire District and one (1) from the South Tucson Police Department. This raised concern from the Regional Advisory Committee (RAC) who questioned the solidarity within the project, although that did not hurt the overall evaluation.

The workbooks were reviewed by an Ad Hoc Committee (interoperability workgroup) and the review was supposed to be based on an applicant's technical merit. The five (5) PCWIN applications, presented under Initiative #1 – Regional System Enhancement, were re-categorized under Initiative #5 – Future State System.

PCWIN Committee members felt that Initiative #5 did not fit the definition of the grant. The Sheriff's Department took that information to the Department of Homeland Security and their concerns were addressed. The only PCWIN workbook given support was the radio shelter at Oatman; a cost of \$140,000.

The Sheriff's Department initiated action with the Department of Homeland Security to re-evaluate the workbooks, which were ultimately brought back for consideration. Awards will be announced in the next couple of weeks.

Mr. Sayers refers to the Committee for questions. He receives no response.
