Re: **January 8<sup>th</sup> Memorial Funding**

At the December 3, 2019 Board of Supervisors meeting, questions arose regarding the amount of money the County has received for the January 8<sup>th</sup> Memorial. This question arose when accepting a pass through grant from the Arizona State Parks Board from the Land and Water Conservation fund, providing an additional \$61,469 for the January 8<sup>th</sup> Memorial.

As of December 2, 2019, Pima County has received \$2,329,576 in donations for the January 8<sup>th</sup> Memorial. Attached is an October 28, 2019 spreadsheet listing the donations. As you can see, there has been substantially more money received for the January 8<sup>th</sup> Memorial than the \$500,000 referenced at the Board meeting.
