Re: **Weekly Pima County Adult Detention Center Snapshot – August 28, 2020**

Please see the attached weekly snapshot of individuals held at the Pima County Adult Detention Complex (PCADC) as of Friday, August 28, 2020. This report covers 1,395 individuals who are held in the PCADC. Of those held in the facility, 1,206 are male and 179 are female; 1,318 are held on felony charges and 67 are held on misdemeanor charges.

Page 2 shows the misdemeanors and felonies. The information is broken down into pending charges versus sentenced to the PCADC or sentenced to the Arizona Department of Corrections. As of August 28, 2020, of those held on felony charges, 1,180 had pending charges; 110 individuals were sentenced to the PCADC by a Court and 21 were sentenced and awaiting transfer to the Arizona Department of Corrections. As of August 28, 2020, for those held on misdemeanor charges, 46 had pending charges and 21 were sentenced to the PCADC.

The Court distribution is also shown on Page 2. For misdemeanors charged Justice Court one individual had pending charges, seven were pre-trial detainees and one individual was sentenced to the PCADC. For Tucson City Court, three individuals had pending charges, 31 were pre-trial detainees and 17 were sentenced to the PCADC. For felonies, 88 were related to Justice Court; 32 related to Arizona State Court with 1,164 from Superior Court.

The report also breaks out drug offenses on Page 3. Of the previous grouping for both felony and misdemeanor charges, only 38 of the total individuals booked were related to drugs. Total booking during the week was 327, with 186 being felony bookings and 138 being misdemeanor bookings.

Finally, Page 4 shows citizenship. Only 78 individuals of the 1,395 inmates held in the PCADC are not United States citizens.








Percentage of PCADC Population Misdemeanors and Felonies






