Re: **Homeless Camps 2019 Annual Summary**

The Regional Flood Control District (RFCD) incurs considerable expense in removing homeless camps and associated debris throughout the year. The final cost for 2019 was \$221,327, twice the costs incurred for 2018. The total trash and debris removed was nearly 100 tons. This material comes from approximately 63 homeless camps removed from the major watercourse system managed by the RFCD.

The attached January 10, 2020 memorandum from the RFCD Director provides more details regarding this subject. If you have any questions or comments, please contact my office.
