Re: **Pima County Bond Programs Semi-Annual Update**

Pursuant to the County's Truth in Bonding Code, I will continue to provide twice a year reports to the Board of Supervisors until all bond projects are complete. At this time, the Pima Animal Care Center has committed the remainder of their bond funds to purchase a mobile adoption vehicle to expand services and increase adoptions. There are six Highway User Revenue Fund (HURF) transportation projects remaining. Since the only remaining bond projects are transportation projects, this report is also being provided to the Transportation Advisory Committee. The status of the remaining HURF bond projects is included below and additional information is maintained on the County's bond webpage at www.pima.gov/bonds. A full report on the HURF bond program was provided to the Board and Transportation Advisory Committee in December, 2020 and can be found at the following link:

Remaining Pima County Managed Projects

1. DOT-32, Kolb Road - Sabino Road to Sunrise Drive: Under construction with completion in the second half of FY 2021/22.
2. DOT-59, Road Repair and Pavement Preservation: Speedway Blvd. – Painted Hills Road to Camino de Oeste and Sarasota Blvd. north of Kinney Road will be complete in late FY 2020/21.
3. DOT-57, Safety Improvements: The following projects are under development or under construction:
 - Speedway Blvd - Painted Hills Rd to Camino de Oeste: Under construction and scheduled for completion in late FY 2020/21.
 - King Canyon Trailhead Parking: Under construction with completion in the third quarter of FY 2020/21.

- Bopp Rd - Sarasota Blvd at Kinney Rd Improvements: Under construction with completion in late FY 2020/21.
- SMART Transportation Data Network: Under development.
- White Elementary School - Pistor Middle School: Project is complete.
- Skyline Dr at Sunrise Dr Intersection Improvements: Under construction with completion in late FY 2020/21.
- Sign Panel Replacement: Procurement of signs is complete.

Remaining City of Tucson Managed Projects

1. DOT-29, Houghton Road - Golf Links Road to Interstate 10: Remaining County bond funding will be contributed to the Valencia Road to Mary Ann Cleveland Way phase of the project that is scheduled to start construction in the fourth quarter of FY 2020/21 and complete in FY 2021/22.
2. DOT-56, Broadway Boulevard - Euclid Avenue to Country Club Road: Construction is underway and scheduled to last for two years. Remaining County bond funds will be spent by end of FY 2020/21.
3. DOT-58, 22nd Street - Interstate 10 to Tucson Boulevard: This project has multiple phases. Construction of the Kino Parkway to Tucson Boulevard phase includes County bond funding. Design is complete and construction begins in FY 2021/22 with completion in FY 2022/23.
