Re: **Brownfields Search and/or Environmental Contamination of the Irvington Place Property**

The property known as Irvington Place Lots 1 through 755 has been negotiated for purchase by Pima County for inclusion in the Kino Sports Complex to develop a major regional practice and tournament soccer facility.

The first step in such a development is acquisition of the necessary property. This acquisition will be placed on the July 1, 2014 Board of Supervisors Addendum, allowing the Board to enter into a purchase agreement with the property owner.

There have been allegations raised about the site being a brownfield or in the vicinity of a brownfield site. I previously forwarded to you a Phase 1 Environmental Site Assessment conducted by Terracon Consultants. I am now providing for your review and information an Environmental Data Resources, Inc. search report within one-half mile of the property. This search indicates there are no national, state or local brownfield sites within one-half mile of the subject property.



Archived status indicates that, to the best of EPA's knowledge, assessment at a site has been completed and that EPA has determined no further steps will be taken to list this site on the National Priorities List (NPL), unless information indicates this decision was not appropriate or other considerations require a recommendation for listing at a later time. This decision does not necessarily mean that there is no hazard associated with a given site; it only means that, based upon available information, the location is not judged to be a potential NPL site.



Most federal and state regulations, as well as ASTM E 1527-05, define this as any tank, incl., underground piping connected to the tank, that is or has been used to contain hazardous substances or petroleum products and the volume of which is 10% or more beneath the surface of the ground (i.e., buried).

	Areas that are typically saturated with surface or groundwater that creates an environment supportive of wetland vegetation (i.e., swamps, marshes, bogs). The Corps of Engineers Wetlands Delineation Manual (Technical Report Y-87-1) defines wetlands as areas inundated or saturated by surface or groundwater at a frequency and duration sufficient to support, and that under normal circumstances do support, a prevalence of vegetation typically adapted for life in saturated soil conditions. For an area to be considered a jurisdictional wetland, it must meet the following criteria: more than 50 percent of the dominant plant species must be categorized as Obligate, Facultative Wetland, or Facultative on lists of plant species that occur in wetlands; the soil must be hydric; and, wetland hydrology must be present.
Wetlands	The federal Clean Water Act which regulates "waters of the US," also regulates wetlands, a program jointly administered by the USACE and the EPA. Waters of the U.S. are defined as: (1) waters used in interstate or foreign commerce, including all waters subject to the ebb and flow of tides; (2) all interstate waters including interstate wetlands; (3) all other waters such as intrastate lakes, rivers, streams (including intermittent streams), mudflats, sandflats, wetlands, sloughs, prairie potholes, wet meadows, playa lakes, or natural ponds, etc., which the use, degradation, or destruction could affect interstate/ foreign commerce; (4) all impoundments of waters otherwise defined as waters of the U. S., (5) tributaries of waters identified in 1 through 4 above; (6) the territorial seas; and (7) wetlands adjacent to waters identified in 1 through 6 above. Only the USACE has the authority to make a final wetlands jurisdictional determination.

SPL	The Arizona Department of Environmental Quality (ADEQ) maintains a database representative of the sites and potential sites within the jurisdiction of the Superfund Program Section. It is comprised of the following elements: 1) Water Quality Assurance Revolving Fund Registry Sites; 2) Potential WQARF Registry sites; 3) NPL sites; and 4) Department of Defense sites requiring SPS oversight. State equivalent to CERCLIS.
WQARF	The ADEQ maintains a database of sites that may have an actual or potential impact upon the waters of the State, caused by hazardous substances. The Water Quality Assurance Revolving Funds (WQARF) program provides matching funds to political subdivisions and other State agencies for clean-up activities. State equivalent to NPL.
SHWS	The ADEQ Zip Acids List (state equivalent to CERCLIS) contains locations subject to investigations concerning possible contamination of soil, surface water, or groundwater. Inclusion of any facility or site on this list does not mean that the location is contaminated, is causing contamination, or is in violation of State or Federal statutes or regulations. The list has been archived and will no longer be distributed or updated.
SWF/LF	State and/or Tribal database of solid waste facilities located within Arizona. The database information may include the facility name, class, operation type, area, estimated operational life, and owner.
SPILLS	The ADEQ maintains a logbook of chemical spills and incidents referred to the Emergency Response Unit.
LUST	State and/or Tribal database of leaking underground storage tanks in the state of Arizona.
UST	State and/or Tribal database of registered storage tanks in the State of Arizona which may include the owner and location of the tanks.
AUL	Activity and use limitations include both engineering controls and institutional controls. DEUR: Declaration of Environmental Use Restriction. A restrictive land use covenant that is required when a property owner elects to use an institutional (i.e., administrative) control or engineering (i.e., physical) control as a means to meet remediation goals. The DEUR runs with and burdens the land, and requires maintenance of any institutional or engineering controls
VCP	State and/or Tribal facilities included as Voluntary Cleanup Program sites.
Brownfields	State and/or Tribal listing of Brownfield properties addressed by Cooperative Agreement Recipients or Targeted Brownfields Assessments.
