Re: **Coronado Foothills Estates**

This memorandum is in response to your memorandum of March 10, 2015 inquiring about the schedule for repair of potholes in Coronado Foothill Estates and sweeping of monsoon debris.

The evidence of County maintenance contradicts claims by others regarding a lack of maintenance for five months. We have reviewed prior service requests and crew day cards and noted the Maintenance Division conducted considerable cleanup in July 2014. The Division has also addressed pothole requests in the subdivision; the last pothole patching occurred in late November 2014, within one month of the request. An inspection this week showed only minor pothole issues. Sweeping of debris from streets is a lower priority, and the sweeping request is pending.

Unfortunately, the streets in the subdivision are rated in "poor" condition. The Department of Transportation is currently conducting an aggressive program of repairing potholes throughout the unincorporated area. As part of that effort, the potholes in this subdivision will be repaired within one month. Sweeping of streets at wash crossings, intersections, and a cul-de-sac will also be completed.

It has now been almost 5 months for residents of Coronado Foothills Estates who have been waiting for their pot holes to be filled and for their roads to be swept of debris that is still present on their neighborhood roads following the 2014 monsoon storms. One resident contacted my office and stated that Skyline Drive and Mesa View continue to be a safety concern for residents.

While my staff continues to ask for a time frame of when their roads will be addressed, residents continue to face dangerous conditions - a result of the debris and sand that has been left on their roads coupled with numerous pot holes.

Please advise as to where Coronado Foothills Estates stands on your maintenance list; going on 5 months to have roads swept and addressed completely contradicts what PCDOT has publicly stated are the maintenance timeframes from your department
