Re: Proposed Changes to Election Precincts for 2014-2015 – Request for input

Per ARS 16-411A the Board of Supervisors shall establish a convenient number of election precincts in the county and define the boundaries of the precincts each year preceding the year of a general election. The Board last established the current number of precincts (288) in 2011. Prior to the Board's action in 2011 the county had previously established 411 election precincts. The reduction in the number of precincts from 411 precincts to 288 precincts was chiefly due to the number of voters who had placed themselves on the permanent early voter list (PEVL).

At the time the Board established precincts in 2011, approximately 50% of the registered voters in the county had placed themselves on the PEVL. Currently over 60% of the voters in the county have placed themselves on the PEVL.

Given the large number of voters who have chosen to have their names added to the PEVL, the Pima County Election Department has identified 83 election precincts that are prime candidates for consolidation with an adjacent precinct. If the proposed consolidations are approved, Pima County would have 244 election precincts for the 2014-15 election cycles.

By reducing the number of precincts, fewer poll workers will be needed, less voting equipment will need to be prepared and transported to/from the polls, fewer seasonal employees will need to be hired within the Election Department, fewer vehicles will be needed to transport election material to/from the polls, fewer Election Day trouble shooters will be needed, etc... However, it is important to note that the anticipated cost savings was not the determining factor in proposing a reduction in the number of precincts. Paramount in making a decision to reduce the number of precincts was the ability for voters to conveniently cast their vote on Election Day.

Request

Accompanying this memo are maps reflecting the proposed changes in each Board of Supervisor District and a spreadsheet reflecting the pertinent data that the Election Department used to make the proposed consolidations.

Would you please review the proposed precinct consolidations and provide input to the Election Department so that the Board may act by December 1, 2013 and establish election precincts for 2014-15?

2014 Precinct Consolidation Criteria

1. Proposed precinct lines conform to Congressional, Legislative and Supervisorial Districts.
2. Consolidation of precincts can occur when the number of voters appearing at the polls has substantially been reduced due to an increase in the number of PEVL voters.
3. Consolidation proposals are based on the number of voters that voted at the polls in the GE 2012 and the number of voters on PEVL. Precincts that had a large voter turnout were not considered for consolidation
4. Facility requirements:
 - a. Room size large enough to accommodate 1 or 2 additional poll workers, voting equipment, and allow for safe entrance/exiting of voters)
 - b. Sufficient parking
 - c. Distance of voting room from parking lot
5. Polling place accessible for voters with disabilities
6. A polling place will be assigned within each precinct, or, if a facility is not available, a facility will be assigned in an adjacent precinct
7. Effort was made to keep traditional polling places
8. Precincts on the Tohono O'odham Nation will not be consolidated
9. Consideration was given as to how many voters could be processed by the election board.
10. With one or two extra poll workers all proposed precinct consolidations can be successfully combined.
