Re: **Geographic Location of COVID-19 Test Sites throughout the Metropolitan Region in Pima County**

Attached please find a map indicating the number of locations within Pima County where COVID-19 testing is being provided. The names of the locations are also shown on the attached listing. The locations have been superimposed over Supervisorial District map to show the distribution of these testing sites by district.

If you have any questions regarding these testing site, please let me know.

The Ellie Town Flowing Wells Community Center site began testing on Wednesday, July 29, 2020. We anticipate that the possible starting date for testing at the City Morris K. Udall Center will occur on August 8, 2020.

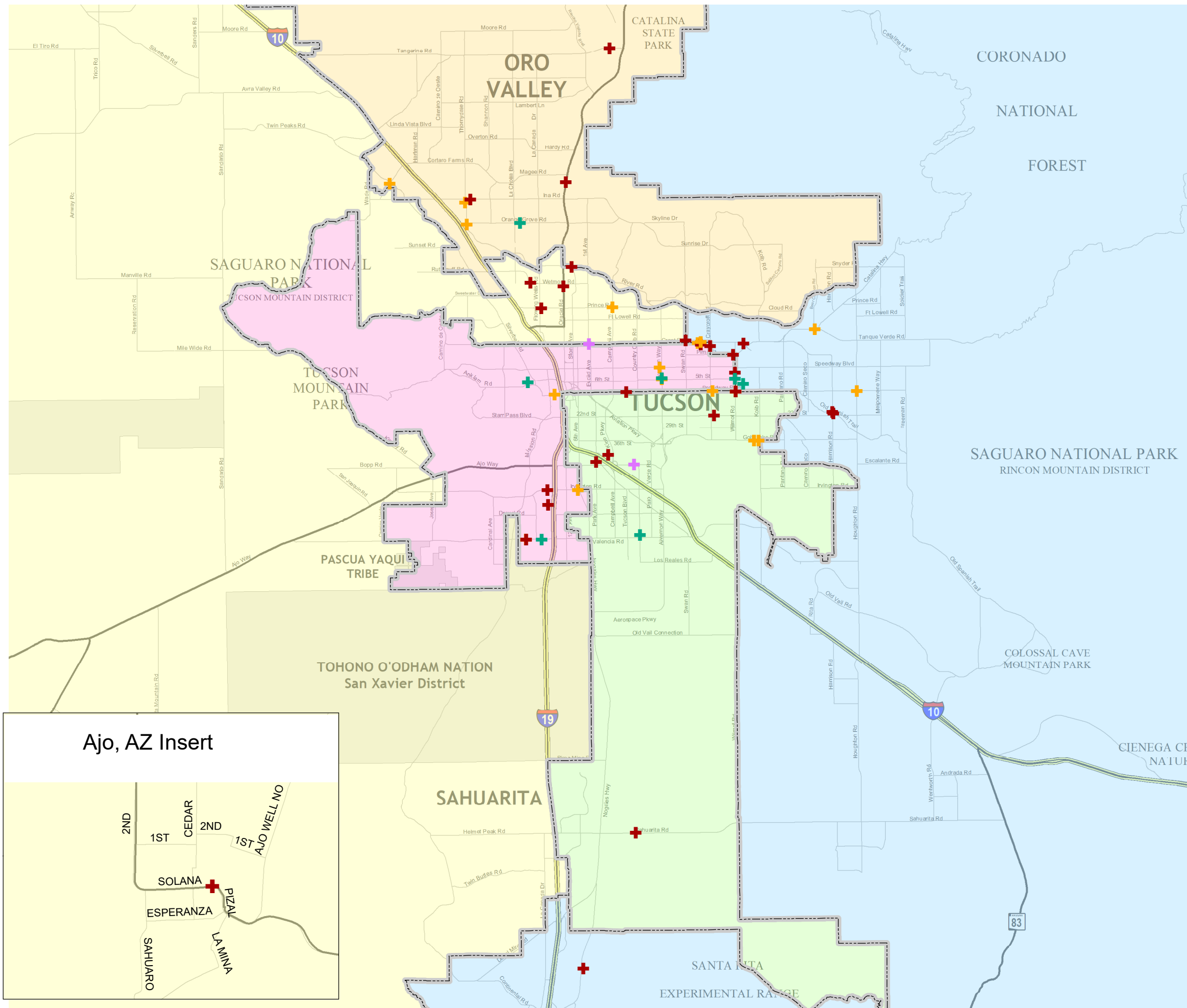
In addition to these regional testing sites, the County has been in discussion with the Arizona Department of Emergency and Military Affairs, regarding Health and Human Service drive-thru testing at a number of remote sites in population centers on the periphery of Pima County, with the intent of offering testing to residents of other counties, Pinal, Cochise and Santa Cruz counties. Because the funding and program is orientated to drive-thru testing, the one location in the metropolitan area for consideration will be the Rillito Racetrack, which because of its connection to both 1<sup>st</sup> Avenue and River Road, as well as the parking area is ideally suited for drive-thru testing.

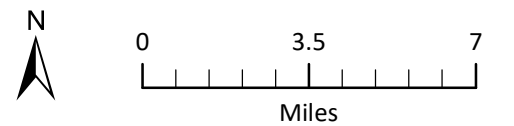
