This request includes, but is not limited to, all responsive correspondence, memorandum and/or e-mail correspondence (regardless of whether the e-mail was sent or received on a personal e-mail account), text messages, or other documents that in any way relate to the Access Road Project. This includes all public records from January 1, 2011 through the present. The request includes all communications, correspondence, emails or other electronic transmissions between each of you, with any constituents, non-profit organizations, or other third parties, with the County Administrator, to or from the County Department of Transportation and to or from the Arizona Department of Transportation.

We request that you provide all responsive documents in their native electronic format, and that the electronic native copy include all embedded metadata. *See Lake v. City of Phoenix*, 222 Ariz. 547, 551, ¶ 14, 218 P.3d 1004 1008 (2009).

If any records responsive to this request are withheld, please furnish an index of such records that have been withheld. *See A.R.S. § 39-121.01(D)(2)*. Please provide the requested documents as quickly as possible or make them available for our review. We will pay all reasonable costs associated with this request. If you have any questions, please do not hesitate to contact me.
