
Major programs and related services provided by the department:

Investigation of Deaths	Some deaths are reportable to the Medical Examiner
Certification of Deaths	Follow requirements concerning certification of deaths that fall under the jurisdiction of the Medical Examiner
Cremation Authorization	Review deaths certified by community physicians in which the family has elected to cremate the remains
Vital Statistics	Local, State and Federal governments track cause and manner of death
Public Health	Inform health department of trends as appropriate; respond to requests for information; pandemic planning; etc.
Organ and Tissue Donation	Work with Organ/Tissue procurement organizations to allow opportunities for donation
Mass Fatality Planning	Work with the Office of Emergency Management & Public Health as necessary; participate in exercises
Law Enforcement and Legal	Partner with LE in the investigation of deaths; provide appropriate information to justice system allow appropriate litigation decisions; testimony
Education	Undergraduate, Medical Student; Resident teaching

Total Cases 2007 - 2016




9376* Deaths in Pima County CY2016
