Suzanne Shields stated that the sediment removal has been completed. The sediment removal was necessary as the U.S. Army Corps of Engineers performs inspections. We are required to maintain flood carrying capacity, if we don't maintain flood carrying capacity, we become ineligible for emergency assistance is there is a flood.

In addition, the District is in talks with the City of Tucson regarding how much of the Santa Cruz River needs to be remapped, prior to any sediment removal.
