FREE FLU SHOTS

The power to stop the flu begins with you! El Rio Health has partnered with Pima County and to offer free on-site flu shots for all Pima County employees, spouses, domestic partners, and any dependents 6 months or older covered on the Pima County medical plan. For participants not covered under the County's medical plan, El Rio Health will accept most major insurance carriers. Flu shots are by appointment only. Pima County locations are only open to County employees. El Rio Health locations are open to both employees and spouses.
