You will enter basic Personal Information to begin your registration process. Follow the Account Information instructions to create your login account. Please note that an email address is required for account set up. Save your username and password information for future use and to access your results online. Once you have completed your registration, you will be able to schedule your screening appointment.


From the home screen, click "Get Started", then "Schedule Now"
