**IFB 214887: EVOQUA SLUDGE COLLECTOR PARTS ADDENDUM 1**

The following clarifications shall be incorporated into **IFB #214887**:

1. **Change** on cover page: **DUE IN AND OPENS**: as follows:

From: "...**JUNE 16, 2016 AT OR BEFORE 2:00 P.M. LOCAL ARIZONA TIME (MST)**..."

To: "...**JUNE 22, 2016 AT OR BEFORE 2:00 P.M. LOCAL ARIZONA TIME (MST)**..."

2. **Clarification** on page 9: **11. INSURANCE**: as follows:

"...**Professional Liability (Errors and Omissions) Insurance** – This insurance is required when soliciting work from licensed professionals. The policy limits shall be not less than \$2,000,000 Each Claim and \$2,000,000 Annual Aggregate. The insurance policy shall cover professional misconduct or negligent acts of anyone performing any services under this contract.

In the event that the Professional Liability insurance required by this Contract is written on a claims-made basis, Contractor warrants that any retroactive date under the policy shall precede the effective date of this Contract and, either continuous coverage will be maintained, or an extended discovery period will be exercised, for a period of two (2) years beginning at the time work under this Contract is completed.

**Examples of Profession Services requiring E&O insurance:** Accounting, Architecture, Asbestos Design, Inspection or Abatement Contractors, Licensed Health Care Practitioners, Legal Services, Engineering Services, or Surveying Services..."

**This section does not apply to this solicitation and is not required at this time. If future changes to the terms and conditions or specifications of the contract require this type of insurance, negotiations will be conducted to add this to the contract.**

3. **Clarification** on page 1 of 17: **4. PRODUCT OR SERVICE SPECIFICATIONS & SCOPE**: as follows:

The specifications are for Evoqua Sludge Collector parts required by Pima County. Alternative or substitute parts **will not** be accepted. This is a no-substitute solicitation.

4. **Add** on page 17 of 17: **44. ISRAEL BOYCOTT CERTIFICATION**: as follows:

**44. ISRAEL BOYCOTT CERTIFICATION:**

Contractor hereby certifies that it is not currently engaged in, and will not for the duration of this Contract engage in, a boycott of Israel as defined by A.R.S. § 35-393.01. Violation of this certification by Contractor may result in action by the County up to and including termination of this Contract.

**All other terms and conditions remain the same.**
