Proposed Use of Right of Way Encroachment License (Attach all of the following):

- o Detailed Site Plans of proposed use of County right-of-way (must comply with Pima County Zoning Code 18.07.030:H)
 - Engineer detailed plans showing proposed location(s) of encroachments or location(s) to be under License. If in a road right of way, show roadway dimensions, centerline and widths. Site plans must include sight visibility triangles indicating sight clearance in all directions.
 - 5" x 11" location map showing proposed location with nearest major arterial roadway intersections, or other prominent landmarks, with section, township and range and parcel boundary lines.
 - A map or sketch of the proposed site relative to other facilities of applicant. The map shall be at a minimum scale of one inch equals 20 feet, although a larger scale may be necessary depending on details to be depicted. The map shall show a horizontal view of right of way lines and location of facilities with distance to edge(s) of pavement and curbs.
 - A map of the proposed site relative to other vertical facilities in excess of 20 feet, whether utility poles, other communication towers, light poles, traffic poles, signs, and so forth, located within 500 feet of the proposed facility.

- A map showing any existing (or currently under construction) communication poles or towers within one mile of the proposed facility.
- A description of the height, mounting style, and number of antennae on the proposed facility, including the pole, tower, ground equipment and other facility requested to be placed in County right-of-way.
- Ground elevations of the site and the elevation of the proposed tower.
- Legal description(s) of area(s) of proposed encroachment/License completed by a Registered Land Surveyor.
- Legal descriptions of adjoining land owned by Licensee, if License is for encroachment of landscaping or other improvements from adjoining property, completed by a Registered Land Surveyor.
- Landscaping plan (if applicable).
- The frequencies that will be used at the site.
