**GARDNER LANE ROAD CLOSURE AND
ROMERO ROAD DETOUR FOR SOUTHBOUND TRAFFIC**

Pima County, Ariz. (Nov. 15) – The Pima County Department of Transportation, the Regional Transportation Authority, and their contractor, Select Development & Construction, Inc., continue work on the Homer Davis Transportation Enhancement Project.

Gardner Lane Closed

Starting Monday, November 18, 2013, at 8:00 a.m. Gardner Lane will be closed to eastbound traffic and northbound traffic on Romero Road wishing to proceed west on Gardner Lane. Gardner Lane will reopen Wednesday, November 27, 2013, at 5:00 p.m.

Crews will be performing manhole reconstruction work and roadway excavation to prepare for paving. Flowing Wells Irrigation District will also be relocating water lines. Motorists may experience minor delays.

Southbound Romero Road Detour

Starting Monday, November 18, 2013, the southbound lane of Romero Road between Gardner Lane and Price Street will be closed. Southbound traffic on Romero Road north of Gardner Lane will be detoured onto westbound Gardner Lane, then south onto Miller Avenue, east onto Price Street and returned to southbound Romero Road (map attached). The southbound lane of Romero Road will reopen on Wednesday, November 27, 2013. At 5:00 p.m.

The Pima County Department of Transportation reminds motorists to obey traffic control signs and speed limits through the construction zone.
