- Pledge of Allegiance

2. Adoption of the Minutes of the June 19, 2014 Meeting

Mr. Neuman produced a page of edits from Ms. Neuman regarding her call to the audience comments. Mr. Janes said we should double check the edits against the recording.

The motion was made and seconded (Hubbard/Kaluzniacki) that the June 19, 2014 Minutes be adopted as written with the incorporation of Ms. Neuman's edits after review against the meeting recordings. Mr. Jacobs objected to the motion saying neither the public nor the Committee have had access to the corrections. Mr. Neuman then read the edits. The motion carried 9-0. Mr. Jacobs abstained from the vote.

3. Call to the Audience

There were no speakers from the audience.

4. Manager's Report

Kim Janes, Pima Animal Care Center (PACC) Chief of External Affairs, offered no comments on the manager's report.

5. Old Business

- Representative of the Disabled Community on the Committee

Mr. Janes said Ms. Helen Mendelsohn was one of four individuals who had expressed interest in filling the position on the Committee. The other three dropped out; Ms. Mendelsohn was present; and her letter of interest was in the meeting packet. Mr. Janes offered that the Committee could vote on whether to approve of Ms. Mendelsohn being part of the Committee, pending approval by the Board of Supervisors, or re-solicit interest. His recommendation was to approve adding Ms. Mendelsohn to the Committee.

The motion was made and seconded (Kaluzniacki/ Hubbard) that the Committee approve of Ms. Mendelsohn as a member of the Committee, pending approval by the Board of Supervisors. The motion carried 10-0.

- Ideas to Increase the Number of Pima Animal Care Center Officers

There was discussion that there had been a recommendation to increase the number of animal care officers, by four positions. Mr. Janes indicated the recommendation was taken to the chain of command and it is under consideration, but no action has been taken yet. He said he would communicate with the Director about the Committee's desire to get the staff added as soon as possible.

- Proposed Ordinance Change to Amend Pima County Code 6.04.180 Adding Further Conditions For Releasing Pets

Mr. Neuman pointed out this ordinance was not voted on by the Board of Supervisors. Mr. Janes expressed appreciation for work by Ms. Emptage, Ms. Schwerin and the County Attorney's Office on the ordinance. He added that he originally was under the impression that the ordinance itself had to be advertised at least 15 days prior to it being heard by the Board of Supervisors, but now understands it is the hearing to discuss the ordinance that must be advertised; therefore there is still some time to fine tune the ordinance before it goes to the Board. The version provided in the meeting packet is trimmed down from the version voted on at the last Committee meeting and was approved by the County Attorney's Office. Mr. Janes pointed out that the Best Friends community cat project (also voted on at the last meeting), with its \$900,000 worth of resources over three years, is tied to the ordinance change in that the new code would allow for participation while the current disposition of animals code does not.

Mr. Neuman provided one page of alternative ordinance language he said he received from Mr. Bagwell in Supervisor Elías' office. The page was titled *Jane Schwerin's Proposed Subsection B*. Ms. Schwerin verbally expressed two minor edits to have the paragraph read as follows.

B. As a condition of any transfer of animals under Subsection A.3., the Pima Animal Care Center shall verify that any organization that receives animals is organized for the pursuit of animal welfare activities, is actively engaged in those activities, does not breed or release unsterilized animals, releases animals only through community cat programs or through adoption into suitable homes after first being sterilized, and complies with the sterilization, placement, and all other applicable provisions of this section, this chapter, this title and other applicable laws. Such verification shall include announced and unannounced inspections of the organization's facilities and records. The Pima Animal Care Center may repossess any animals and their offspring from any organization that is not in compliance with these conditions, and shall repossess these animals if the organization is not in compliance with the mandates set forth in Subsection A.3., or if the organization or its personnel violate a cruelty law. Any organization wishing to receive animals must agree in writing to the terms of this Section.

Ms. Schwerin went over her version. She was against the use of the word “primarily” in the version provided by staff, wherein it stated, “primarily organized for the pursuit of animal welfare activities.” She said cautioned that we don’t know what other activities would be. She pointed out the language prohibiting organizations that breed animals from receiving PACC animals, saying this is to prevent groups from keeping and breeding animals from PACC for a number of years before eventually sterilizing them and placing them in a suitable home. The language only allows rescue organizations to release sterilized animals and only allows for release of animals to a suitable home or through a community cat program. This is designed to prevent, for one example, the release for the purpose of veterinary training. She also stressed the “shall repossess” portion of the language.

Discussion brought out that a number of groups do both rescue and breeding activities. The aforementioned ordinance language would not allow transfer of PACC animals to organizations doing both. Ms. Emptage said this provision is to prevent breeders from retrieving an animal unaltered under the guise of being a rescue foster. There were questions and speculations about whether or not individuals who are employees of, or volunteers with rescue organizations are allowed to breed animals independent of the organization without disqualifying the organization under the “not breed” requirement. In response to a question Mr. Janes said currently PACC alters all the animals possible prior to placing them with a rescue group. However, if the animal is not altered, it is stipulated in writing that the rescue organization will rehabilitate the animal and alter it as soon as possible, and not allow it to become pregnant. In response to another question Mr. Janes indicated there are several breed specific rescue organizations that PACC has been working with.

The motion was made and seconded (Hubbard/Smith) that the Committee approve of the ordinance as edited by Ms. Schwerin. The motion carried (10-0).

- Schedule, Number and Training of Department of Corrections Inmates

Mr. Janes reported that the issues with the Department of Corrections inmate shortages still exist as reported at the last meeting. Alternatively, staff had a very positive meeting with Pima County Adult Detention Center (jail) leadership and it looks like the jail will be able to meet PACC’s need for inmates. However, there are logistical issues that will need to be worked out first and these issues might take months to work through.

6. New Business

- Free Adoptions

Mr. Neuman said there had been a lot of discussion by the volunteers about free adoptions and he had printed out about 15 to 20 pages of comments regarding free adoptions; most comments were not in favor of free adoptions. Comments include that such a practice would diminish the value of the animals. Mr. Neuman said he intended to circulate the comments to the other Committee members.

Mr. Neuman added that there recently was a meeting which included the Adoption Coordinator (Ellie Beaubien) and the volunteer Adoption Counselors. He said he received feedback from approximately 17 of the volunteer Adoption Counselors who attended. He referred to the adoption survey which asks things like do you have another dog and do you have a fenced yard. He then pointed out that when an Adoption Counselor tries to say a certain animal is not a good fit based on survey information, they are told to let the animal go to the adopter, because the individual is cleared for an animal. Mr. Neuman suggested there could be negative consequences resulting from this practice, such as returned dogs or a dog jumping a fence and then biting someone. He questioned what the purpose of the survey is if it’s not being used to

match individuals to appropriate dogs. He said that the Adoption Counselors are not in concert with Adoption Coordinator. Ms. Schwerin pointed out that the code calls for placement in a "suitable home," therefore the code allows for determination of suitable or unsuitable matches.

During the Adoption Coordinator / Adoption Counselors discussion Mr. Jacobs made a point to object to the discussion, questioning what it had to do with free adoptions or any other item on the agenda.

- Customer Service

Mr. Newman said he had placed this item on the agenda, but now wishes to table the item.

- Progress Report-Shelter Managers-Chief of External Affairs, Chief of Operations, Shelter Manager

Mr. Neuman requested Mr. Janes talk about his progress report. Mr. Janes referred to the document dated July 14, 2014 regarding the July 17, 2014 Advisory Committee Agenda Items. Mr. Janes said the document was in response to requests and agenda items. The ordinance was already discussed under old business. Mr. Janes discussed the leadership modification by referring to an updated organizational chart for PACC, as well as Functional Job Descriptions for the Chief of External Affairs, the Chief of Operations and the Shelter Operations Manager, all provided to the Committee (all attached). He pointed out the significant accomplishments section (page 2) of the July 14 document and read the section about key events facing the Center (page 2).

Mr. Neuman said he had asked for an update as to what it was that had occurred as a result of splitting up the shelter manager's position three different ways into the positions currently held by Mr. Janes, Ms. Barney and Mr. Ocano. Mr. Janes stated that Mr. Ocano's job didn't change and that prior to the leadership modification Mr. Janes was not doing any of Mr. Ocano's current job duties. Mr. Janes said Mr. Ocano manages the shelter section, not the Center. The animal care center manager position was split in two with Mr. Janes being assigned by the Health Department Director as retaining the ex-officio member position on the Advisory Committee. Mr. Janes said that an accomplishment relating to the leadership split, from his perspective, is that he was able to devote appropriate attention to the ordinance change, which he would not have been able to do while dealing with the day to day operations of the Center. He added that interactions with cities and towns are now getting necessary attention as well.

Mr. Neuman asserted that many of the accomplishments cited in the report largely have been due to volunteers. He continued that items in the list don't address issues the Committee has been talking about for almost four years. He passed out a list entitled *Lack of PACC Support and Action*, (attached) which included 22 items. He said he walked through PACC today and it looked good, but that was because staff knew Committee members were doing a walk through. The 22 items were things he said haven't been corrected in four years.

Mr. Neuman passed out a written motion (attached) to permanently remedy the restated 22 items within 60 days. The motion also addressed an extension, if required.

Mr. Jacobs asked what agenda item the motion was related to, to which Mr. Neuman replied to the Advisory Committee Executive Secretary's memorandum meeting feedback and update which included the accomplishments of the three different positions, Mr. Ocano's, Ms. Barney's and Mr. Janes positions. Mr. Jacobs expressed concern in that he felt the public should have had 24 hours' notice of the proposed action.

There was discussion back and forth as to whether or not to proceed or delay the motion to the next month's meeting. Discussion also touched on Ms. Barney not attending meetings and possibly requesting she attend the next meeting. Mr. Janes said he would pass on any such a request, if made, to the Director for consideration.

The written motion made by Mr. Neuman was seconded by Dr. Kaluzniacki. The motion carried (9-0). Mr. Jacobs abstained from the vote.

A motion was made and seconded (Marshall/Kaluzniacki) that Ms. Barney and Mr. Ocano be present at the next Advisory Committee meeting to discuss an update on the previous motion of 22 items. The motion carried (9-0). Mr. Jacobs abstained from the vote, saying he believed the action violated open meeting law.

After the vote Mr. Neuman said the meeting will be "here" (at the regular PACC venue). Discussion then turned to the possibility of taking the Committee's objection to Ms. Barney not attending the Committee meetings as requested, to the Board of Supervisors; the Committee's reporting to the Board in general; and who sees the Committee's draft Board of Supervisors report prior to it being signed. Mr. Janes cautioned that electronic exchanges of information back and forth involving the entire Committee could be considered holding meetings without announcing them.

- Update on Volunteer Program

Mr. Janes had provided a document (attached) for this agenda item. There was no discussion on this item.

- Advisory Committee Executive Secretary's July 1, 2014 memorandum RE: June 2014 Meeting Feedback and Update

Mr. Janes had provided a document (attached) dated July 1, 2014 on this item. There was no discussion.

- Mandatory Spay / Neuter

Ms. Emptage said she had placed this item on the agenda, but now wishes to shelf the item. Ms. Hubbard pointed out that members of the audience came to speak regarding this agenda item. Ms. Schwerin requested the item be put back on the agenda. Mr. Neuman said members of the audience may speak on the topic at the second call to the audience.

- Animal Care Center Related Road Signage

Mr. Marshall said that per the Department of Transportation (DOT) between 140,000 and 180,000 cars travel on Interstate 10 (I10) by exit 252 (El Camino del Cerro) daily and he was interested in getting PACC signage on I10 on either side of that exit. He added that there already is a sign on El Camino del Cerro directing drivers to PACC. Mr. Janes' office had already done some research on this and DOT said PACC did not meet their criteria for signage; however, there is a process to appeal for an exception which Mr. Janes' office will look into.

7. Animal Welfare, Dangerous Animal Cases and Holds for the Month of June

There was no discussion on this item.

8. Donations: 1,301 individuals gave a total of \$30,389 during the month of June.

Mr. Neuman referred to the June donations breakdown and asked where the general donations dollars, \$12,833.35 in June, go. Mr. Janes said he would have to look it up specifically, but much of that amount, over \$7,500, went for a washer and dryer. He added that \$2,000 was a small grant that went for advertising. He discussed that general donations dollars are used for whatever the need is and could be used a few months later, with expanded medical expenses often being the target of these funds.

9. Complaints and Commendations: Three complaints and one commendation were received by staff during June.

Ms. Emptage made it a point to commend Mr. Janes for his work, even while on vacation, on the ordinance. There was no other discussion on this item.

10. Call to the Audience

There were five speakers from the audience: Sara Dent, Michael Santos, Jessica Shuman, Helen Mendelsohn and Marcie Velen.

Ms. Dent identified herself as a concerned citizen, attorney, animal person and rescue board member. She spoke against mandatory spay and neuter (SN) programs, saying they haven't succeeded in reducing shelter intakes and are not supported by any major animal welfare agencies, including Best Friends. She does, however, support low cost SN programs. She contended that mandatory SN programs punish the poor and that pet owners primarily do not alter their animals due to lack of resources, not due to obstinacy or by choice. She added that mandatory SN is hard to enforce and a waste of PACC's limited resources. Ms. Dent said the ordinance seems unnecessary and seems to be cutting off resources when agreements are already in place. She also discussed that breeders would not use an un-papered shelter animal for breeding.

Mr. Santos identified himself as the founder and President of All American Bully Buddies Rescue, and former board member and current volunteer with No Kill Pima County. He said Ms. Dent addressed most of his issues, but added that mandatory SN often targets specific breeds, more often than not, pit bulls. He said breed discriminatory legislation will be met with considerable opposition.

Ms. Shuman introduced herself as the Director of Tucson Cares, an animal welfare and advocacy organization, a board member with No Kill Pima County, a PACC volunteer, and Chair of the Trap, Neuter Return Committee of the Pima Alliance for Animal Welfare. She encourage the Advisory Committee to do research before considering things such as mandatory SN programs, which she said increase impounds and owner relinquishments, which then increases shelter killing. She said that free adoptions moves animals out of the shelter. She used the word "shameful" to express her opinion of the few dissenting Trap Neuter Release votes (June meeting), citing the program as lifesaving and pointing out PACC's lack of resources for meeting community needs. Ms. Shuman said she appreciates the suggestions to help dogs at PACC, but said that cat conditions are often overlooked and need improvement also. She requested cats be on the agenda. She suggested the Committee offer solutions, not just demands; cautioned that low resources make issues hard to address; and cautioned that pressure to achieve certain improvements could result in what she called heavy handed marking. She went on to give examples of approximately eight animals that were marked for euthanasia for different reasons that included hair loss, pregnancy, jumping a fence, being overweight and ringworm.

Ms. Mendelsohn referred to her service dog, Hope, and said Hope was a rescue animal from a rescue that also breeds. She said the breeder would not use a rescue animal for breeding. She encouraged the Committee to let more rescue groups take animals (from PACC) or there will be more euthanasia.

Ms. Velen said there are a number of issues that different animal welfare agencies don't agree on, but they all agree that mandatory SN is not a solution. She said mandatory SN makes people afraid to bring in their animals for vaccinations and veterinary care; drives down licensing; increases euthanasia; and is difficult to enforce. She added that the ordinance got out of hand. She said it would be nice for the list of 22 items to be on the agenda, but added that the cat conditions are worse.

11. Announcements and Schedules

Mr. Janes said PACC's Christmas in July adoption event will be this Saturday, and added that the Center is attempting to have 90 percent of the adoptable animals altered for the event, so that the animals are ready to go to their new homes.

12. Next Meeting – August 21, 2014

There was no discussion on this item.

13. Adjournment

The meeting adjourned at 7:47 pm

1. Call to Order

- Pledge of Allegiance

2. Adoption of the Minutes of the May 15, 2014 Meeting

After a brief discussion, the motion was made and seconded (Marshall/Hubbard) that the May 15, 2014 Minutes be adopted as written. The motion carried 6-0. Ms. Schwerin abstained from the vote.

3. Call to the Audience

There were no speakers from the audience.

4. Manager's Report

Kim Janes, Pima Animal Care Center (PACC) Chief of External Affairs, addressed the Committee. Mr. Janes' new assistant Michael Schlueter was reintroduced and venue specific information was shared. Mr. Janes talked about the three-month ASPCA Rachel Ray Challenge. Last year PACC had 3,046 live releases during the same time frame and needs a daily average of 33.11 to achieve that total again. PACC is averaging 42.9 per day during the first 18 days of the Challenge, but would need 54.35 per day to achieve the goal of 5,000 by the end of August. During May 2014 PACC had a live release rate of 80 percent, with a year-to-date rate of 76 percent. In March 2014 the average live release rate was 35.97; in April it was 33; and in May it was 41.2. Discussion turned toward grading performance in the ASPCA Rachel Ray Challenge. There are five divisions in the Challenge. In each division the best at improving live releases, according to their formula, is awarded \$25,000; best overall is worth \$100,000; and there are other monetary incentives. Discussion brought out that PACC's average cost per outcome is approximately \$115, per Mr. Janes.

5. Old Business

- Ideas to Increase the Number of Pima Animal Care Center Officers

Mr. Neuman discussed that enforcement numbers are down. Mr. Janes responded that there have been less welfare responses; however, they have been more complicated and time consuming. Item to be continued to next meeting.

- Schedule, Number and Training of Department of Corrections Inmates

Mr. Janes reported that the current contract with the Arizona Department of Corrections (DOC) calls for 14 inmates in the morning and eight in the afternoon, but DOC has struggled to provide these numbers and the typical crews are 10 or 11 in the morning and six or seven in the afternoon. Staff is exploring options, including County inmates, to provide a sufficient cleaning workforce. Mr. Neuman asserted that every kennel is not being cleaned every day, stating that recently a number of times in the B Room animals were missed, not getting their kennel cleaned and not getting fed. Mr. Janes stressed that the standard is that animals are fed every day and have their kennel cleaned at least once per day; and he encouraged volunteers to continue to bring these issues up as they see them. Mr. Neuman commented that Ms. Kristen Barney, Chief of Operations, told him that staff cannot get their jobs done because of numerous interruptions from volunteers. He expressed concern that he doesn't want an "us versus them" dynamic between volunteers and staff. Ms. Emptage interjected that she has recently received a large volume of e-mails from volunteers, and requested that the volunteers go through Mr. Neuman as their representative in lieu of multiple members of the Committee.

- Tucson Kennel Club Advisory Committee Representative Pat Jacobs

Mr. Janes indicated that the Tucson Kennel Club has officially designated Mr. Jacobs as their representative on the Committee, and his appointment information has been sent to the Clerk of the Board for the Board of Supervisors' ratification of appointment at their July 1 meeting. Once appointed by the Board and Mr. Jacobs completes the Loyalty Oath of Office, he will be an official member of the Committee. Mr. Jacobs was present for the meeting.

6. New Business

- Committee Access to the Pima Animal Care Center Manager

This item was brought up by Mr. Neuman (after the Pledge of Allegiance) in relationship to attendance. He asserted that the actual manager of PACC is not present for the Advisory Committee meeting. Recently PACC managerial duties were split between Mr. Janes and Ms. Barney. Mr. Neuman, referring to the by-laws, cited that the Committee serves in an advisory capacity to the Manager of the Pima Animal Care Center, who is designated to serve as an ex-officio member of the Committee, and therefore contended that Ms. Barney, who is the active manager at PACC, should be present for Committee meetings. Committee members expressed concern that answers to questions could take a long time in the current managerial dynamic. Mr. Janes said there should be no difference in answer flow, in that if an answer is available it is given, and if an answer is not known immediately, then it will be researched and brought to the Committee. He also asserted that he is the PACC Manager for the purposes of the Committee, as assigned when the duties were split.

The motion was made and seconded (Schwerin/Marshall) that the Committee requests Ms. Barney attend the Committee meetings. The motion carried 7-0.

- Advisory Committee Meeting Venue

Ms. Emptage brought up that she felt the Committee meetings should be held at PACC. Mr. Janes pointed out that changes are being made, with forums and discussions being held about animal welfare, not just inside the PACC facility, but in all areas. He continued that he is open to discussion on the Committee's role and input.

The motion was made and seconded (Neuman/Hubbard) that the primary Committee meeting location be at PACC, except when circumstances warrant differently. The motion carried 7-0.

- Staff Requesting Committee Support of Community Cat Project Contract

Mr. Janes indicated staff is in the final stages of forming an agreement with Best Friends Animal Society to provide for an infrastructure for a community cat trap, neuter and return (TNR) project, which is a shift from a trap and kill route. Best Friends will trap and receive community cats brought to the shelter, take them to be neutered and return them to where they came from. Ms. Emptage expressed concern for cats being returned to areas where homeowners do not want the cats present. Mr. Janes said the program includes an infrastructure to help address community concerns.

The motion was made and seconded (Hubbard/Neuman) that the Committee support this project contract. The motion carried 5-2 (Emptage, Schwerin – opposed).

Ms. Emptage requested mandatory spay and neuter be an agenda item at the next meeting.

- Staff Requesting Committee Support of Proposed Ordinance Change to Amend Pima County Code 6.04.090 and 6.04.180 to Allow Release of Unclaimed, Unaltered Animals to a Duly Incorporated Humane Society or Other Nonprofit Corporate Organization Devoted to the Welfare, Protection and Humane Treatment of Animals

Mr. Janes indicated the Pima County Attorney's office requested that the code be change to allow for unaltered animals to be transferred to a humane society or other nonprofit animal welfare organization, subject to the same animal altering requirements. Currently the only outcomes specified in code are adoption and euthanasia; and currently the code does not allow for unaltered animals to leave the facility. The change streamlines and cleans up the release of animals to rescue partners. Ms. Emptage voiced concern that in the past a rescue organization provided animals for veterinary training, which is not placing an animal in a suitable home. Mr. Janes pointed out that neither the current code nor the proposed ordinance can prevent that potential problem, and if such a practice is discovered, then PACC would cease its relationship with the organization. Ms. Schwerin expressed concern that ownership is transferred without alteration; there is no proof of sterilization; no inspection of records; no monitoring or inspection. In response to a question Mr. Janes said there is a process to confirm the organization is valid, but it doesn't involve inspection. It was also pointed out that Ms. Schwerin is reworking these codes and will have a proposal in the near future. Mr. Janes requested the committee move to recommend the proposed ordinance to the Board of Supervisors.

The motion was made and seconded (Hubbard/O'Donnell) that the Committee move to recommend the proposed ordinance as requested by Mr. Janes. The motion carried 4-3: (Barrick, Hubbard, Marshall, O'Donnell – for) (Emptage, Neuman, Schwerin – opposed).

- At Large Animal Attacks and Vet Care

Ms. Emptage shared knowledge of a number of instances where individuals are walking their dogs on a leash when an at-large dog, typically pit bull or sheppard mix, attacks the owned dog. The attacking dog runs away. She voiced concern over the veterinary costs for the dog owners and the process to hold dog owners responsible for expenses caused by their loose dog. She posed the questions what can be done; what do we tell people? She indicated PACC typically does not respond to at-large dog complaints. Mr. Janes indicated PACC

responded to 57 animal attacks in May, but an in-progress attack is more of a priority than one that is over. Ms. Emptage asked about the national standard for enforcement officers and Mr. Janes said he would seek out that information.

- Tent Utilization

Mr. Neuman inquired about tent utilization. Mr. Janes indicated there are 40 kennels not in use. The usage was cut back in response to noise complaints. Additionally in the summer heat, the temperature has also been a concern. No new tent noise complaints have been lodged in the last week, and staff is pursuing solutions to facilitate permanent full occupancy.

- Committee Recognizing Pima Animal Care Center Staff

Ms. Emptage initiated discussion, saying staff needs a pat on the back, and suggesting some type of employee recognition. Discussion brought out that the Committee had a high level of appreciation for staff; however, although awards and recognitions lift some up, they also can draw ire from others. Mr. Janes briefly touched on the Department's "Happy Gram" peer recognition and said he would be sure to pass on the Committee's appreciation of staff.

- Representative of the Disabled Community on the Committee

There were no prospective representatives of the disabled community present seeking a position on the Committee. Staff will check on the individual expected to address the Committee.

- Use of Kennels (specifically change to front adoption kennels to include reasoning behind which dogs get individual kennels and plans for individual kennels for all)

Mr. Neuman spoke about the adoption row kennels that are being utilized as 18 larger two sided kennels instead of 36 kennels. He reported hearing two different reasons for this practice, one was safety and the other was dogs are more likely to be adopted out of the bigger kennels. However, he argued this practice has a negative impact in the other kennels, including safety issues and lesser likely adoptions for animals grouped together, as well as the feeding issues (next item). Mr. Janes pointed out that increased adoption numbers, from 33 per day in April, to 41 in May, to 43 so far in June, have been in conjunction with going to the practice in discussion. Mr. Neuman requested to know where the dogs were adopted from. Mr. Janes acknowledged that there is stress for the animals, but pointed out that fewer animals have to die than did six months or a year ago. He concluded by saying we do need to continue to work on this.

- Feeding of Dogs

Mr. Neuman stated that it is an ongoing practice to feed multiple dogs together when they are kept in the same kennel. He said fights break out and some animals don't eat. Staff has informed him that the statistics don't show dogs are fighting; however, if staff is not present to witness the fight, then it will not be recorded in the statistics. Mr. Neuman said he recently went to PACC ten times during feeding time and there were fights every time, but staff was not present to witness the fights he observed. Mr. Neuman requested this issue be addressed. Suggestions included reconsidering the kennel usage practices on adoption row (item above); rotating animals into the adoption rows kennels; and feeding dogs while on their walks.

As part of new business, Mr. Marshall requested PACC signage on Interstate 10 and the reevaluation policy for animals returned by adopters, for behavioral issues, be agenda items at the next meeting.

7. Animal Welfare, Dangerous Animal Cases and Holds for the Month of May

There was no discussion on this item.

8. Donations: 1,330 individuals gave a total of \$24,936 during the month of May.

Mr. Janes indicated this is only monetary donations.

9. Complaints and Commendations: Three complaints and one commendation were received by staff during May.

There was no discussion on this item.

10. Call to the Audience

There were three speakers from the audience: Cathy Neuman, Marcie Velen and Mariana Parker.

Ms. Neuman said she volunteers at PACC four to five days a week and sees issues like the group feeding of dogs. She said there is a dog fight every day. Sometimes the volunteers identify a thin dog that hasn't been eating, but sadly it takes days to notice and the dog is half starved. The group feeding practice needs to be addressed. She echoed Mr. Neuman's comments (New Business – Use of Kennels) saying the adoption row kennel practice causes a loss of 18 kennels. She told about finding a small dog, Osito, cowering in a kennel with larger dogs. The small dog had a wrap on his mid-section. The wrap was around his penis, which was severely swollen. The dog had stitches that were ripped open and was bleeding. Ms. Neuman took Osito to Dr. Wilcox who indicated there was no record of how or why Osito was in the condition Ms. Neuman found him, and added that her intervention saved the dog's life.

Marcie Velen, from No Kill Pima County, said that cats, due to the layout of PACC, do not get nearly as much traffic and attention. Her point was that issues with dogs are also issues with cats; they just go unseen more. She also said she works the Help Desk and in approximately four weeks the Help Desk has successfully encouraged 45 diversions and received a matching pledge of up to \$2,500 for the Help Desk.

Mariana Parker, also a volunteer at PACC, spoke about difficulties in getting animals out to rescue groups in a timely manner. She said animals requiring medical care are not being cleared in time. Ms. Parker read a statement from a rescue partner regarding Wiggles the boxer. The rescue partner was at PACC one morning to pick up the dog and requested Wiggles' legs get rewrapped since the dog removed the bandages and was biting at the open wounds. The person was told that it would be done in the afternoon. The person was also told she couldn't take the animal because he wasn't cleared by Dr. Wilcox who wasn't present. After much effort the dog was finally released. Another example given was an attempted rescue of a cat with an injured eye. It took two weeks for the rescue group to get the cat. Mr. Parker added that there is an issue concerning watering animals in the back where water buckets are used. She said a volunteer observed an employee fill a bucket with a high powered hose through the chain link, soaking the kennel and dogs in the process. Ms. Parker requested the watering procedure be addressed to prevent this.

11. Announcements and Schedules

Mr. Janes: The art auction scheduled for June 19 has been postponed. Ms. Hubbard: The Humane Society is providing a distemper/parvo vaccination clinic on June 28 on Roger Road starting at 7:00. Mr. Neuman: There is a roller derby event Saturday benefitting an animal welfare organization.

12. Next Meeting – July 17, 2014

There was no discussion on this item.

13. Adjournment

The meeting adjourned at 8:05 pm

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, RELATING TO ANIMALS; AMENDING THE PIMA COUNTY CODE BY AMENDING CHAPTER 6.04, ANIMAL CONTROL REGULATIONS

THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, FINDS THAT:

- 1) The Board of Supervisors of Pima County, Arizona, has authority under A.R.S. § 11-1018 to adopt animal control regulations.
- 2) It is in the best interests of the County to reduce its homeless animal populations by amending certain provisions of the Pima County Code to permit the Pima Animal Care Center:
 - a) to transfer unaltered, unclaimed animals to duly incorporated nonprofit animal welfare organizations for sterilization and adoption into suitable homes; and
 - b) to participate in programs providing for the trapping, sterilization, and return of healthy community cats.

THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA:

SECTION 1. Title 6, Section 6.04.180 of the Pima County Code is amended to read as follows:

**Chapter 6.04
ANIMAL CONTROL REGULATIONS**

Section 6.04.180 Disposition of animals.

A. Any animal forfeited, abandoned, ownerless or unclaimed, and any other animals to be disposed of by the county enforcement agent, shall be:

1. placed by adoption in a suitable home or
2. humanely destroyed; or
3. transferred to a duly incorporated humane society or other nonprofit corporate animal-welfare organization devoted to the welfare, protection and humane treatment of animals. Transferred animals shall be placed by adoption in a suitable home after first being sterilized; or shall be humanely destroyed; or may be released as part of a community cat program.

B. The Pima Animal Care Center shall verify that any organization that receives animals under subsection (A)(3) is primarily organized for the pursuit of animal welfare activities, is actively engaged in those activities, and complies with the sterilization, placement, and all other applicable provisions of this section, this chapter, this title, and other applicable laws. Such verification shall include announced and unannounced inspections of the organization's facilities and records. The Pima Animal Care Center may repossess any animals and their offspring from any organization that is not in compliance with these conditions, and shall repossess these animals if the organization or its personnel violate cruelty laws. Any organization wishing to receive animals must agree in writing to the terms of this subsection.

C. For the purposes of this section, a "community cat program" means a program in which healthy, free-roaming cats are sterilized, vaccinated against rabies, ear-tipped, and returned to the location where they were found.

SECTION 2. This Ordinance is effective 30 days after the date of adoption.

Dear Chair and Members,

An amended version of Ordinance Proposal 6.04.180 is provided for your consideration and support.

The following report and associated attachments regarding PACC status, leadership responsibilities and organization are provided for your information.

As you may recall, on May 9, 2014, Dr. Francisco Garcia contacted you to advise you of additional resources to be added to Pima Animal Care Center. In particular, he reported:

“Effective May 12, 2014, I have separated the leadership functions at PACC into two broad areas. The first is to create a position of Chief of External Affairs which will be responsible for inter-jurisdictional relationships, financial operations, external stakeholder engagement and policy development. I am grateful that Kim Janes has taken on this challenge which will call upon his vast experience building relationships with the city and towns as well as the myriad of community stakeholders. The second new role is that of Chief of Operations. This individual is tasked with day to day operational over site for PACC including shelter operations, enforcement, licensing, live release, clinical services, volunteer coordination and outreach. Kristin Barney has accepted this assignment on a temporary basis for the next six months. She is an ideal candidate for this interim position because of her previous professional work and her experience developing staff. Although their official County title will not change, their functional title and responsibilities have been redefined.”

In implementing this change, staff updated the attached organizational structure and developed the attached functional job descriptions for the Chief of Operations and the Chief of External Affairs. As you will notice, the realignment of duties bifurcated the numerous responsibilities placed on a single position through meeting the more than full time Center management needs on campus with the Chief of Operations while assigning to the Chief of External affairs the responsibility to serve with and support the Advisory Committee and other community partnerships as well as effectively manage inter-jurisdictional, external department and internal County support services necessary to keep up with the

very welcome but swiftly expanding service demands being placed on enforcement, licensing, shelter, clinic and outreach operations.

Though the transition into the new leadership structure is still a work in progress, some of the significant accomplishments include:

1. May and June monthly live release rate sustained at 80%.
2. Caring for, treating and rehabilitating record numbers of animals each day.
3. Initiated the sterilization of unaltered forfeited pets as soon as possible, also known as pre-sterilize, so they can go home the day they are adopted
4. Negotiating with County Corrections to contract with it to replace current inmate and vendor cleaning crews with County inmate cleaning crew. Projected start date for County crew is no later than December 1, 2014.
5. Improved staff recognition program.
6. Established recurring volunteer forums.
7. Successful implementation of the Challenge.
8. Added air conditioning to the tent.
9. Conducted extensive negotiations and completed the Community Cat Program contract with Best Friends Animal Society; scheduled to be presented to the Board of Supervisors at their August 5 meeting with an implementation date of September 5, 2014.
10. Developed a proposed Pima County Ordinance change to allow PACC to participate in progressive animal welfare non lethal animal management solutions. Staff is soliciting input on the change from citizens and stakeholders and is advertising in the Daily Territorial on July 18 and 21 prior to being considered by the Board of Supervisors at their August 5, 2014 regularly scheduled Board meeting.
11. Developing a comprehensive animal care ordinance change.
12. Initiated discussions with cities and towns to initiate a jurisdiction coordinating council. First meeting with city and town managers or their representatives scheduled August 27, 2014.
13. Completed a comprehensive review and update of four (4) city and town inter-governmental agreements.
14. Added recurring staff section presentations to the Advisory Committee.
15. Developing and providing Bond related background information and educational feedback to cities and towns elected officials and staffs, citizens, stakeholders and partners.

Key events facing the Center over the next few months include:

1. Win the Challenge by August 31, 2014.
2. Initiate Community Cat Program by September 5, 2014.
3. Achieve 90% live release rate by October 2014.
4. Complete and present to the Board of Supervisors and to the cities and towns where applicable a comprehensive animal care ordinance change by January 31, 2014.
5. Collaborate with other jurisdictions to develop modern animal care statutes and implement those practices by July 2015.
6. When the Bond passes, complete design, develop and construct the new Pima Animal Care Center by November 2018.

The Health Director will reassess the effectiveness of this structure within six months.



RE: June 17, 2014 Meeting Feedback and Update

Dear Chair and Members,

The following information is provided for your consideration and information.

During the June 19, 2014 Advisory Committee Meeting, the Committee:

- Moved and passed a request to the Health Director that the meeting be held at the Pima Animal Care Center (PACC) unless for special circumstances.

The Health Department Director has considered and approved the request to move the meeting back to PACC. In the future, the regularly scheduled meeting will be held at PACC.

- Moved and passed a request to the Health Director to have PACC's Chief of Operations (COO) regularly attend the Advisory Committee Meeting.

The Director does appreciate the committee's interest in having the COO present on a regular basis but respectfully must decline this request of the Committee. Mr. Janes is the designated Executive Secretary and is responsible to be prepared for each meeting. However, on occasion, the Executive Secretary will coordinate committee member requests for staff attendance due to specific agenda items as well as staff presentations and attendance similar to the adoption program presentation recently provided to the Committee.

- Requested how PACC officer's per capita compared to a national standard.

According to the National Animal Control Association:

"Although there is no universally accepted scientific methodology for determining the number of Animal Control Officers needed in a given jurisdiction, there are three models that are variously employed in Animal Control in determining an appropriate number of personnel.

- Some jurisdictions have attempted to evaluate the estimated growth in residential and business activity to predict the need for additional personnel.
- The use of comparative data from the NACA Data Survey factoring in population, square miles served, and whenever possible, enforcement responsibilities.

- The "calls for service" model is used primarily as a workload indicator because the data represents a recognizable and readily measurable demand for Animal Control service. Comparing the number of calls for service from one jurisdiction to another, however, can be very tenuous, because of the variety of calls and the response to Animal Control efforts to encourage citizens to call on any perceived problem.

Determining the number of officers requires an assessment of citizen calls, officer-initiated calls, citations, written warnings, assisting outside agencies, the need for safety and security, a flexible beat structure, time spent on investigations, preventive patrol time and the specific types of service that the public wants and expects.....

In most situations, NACA utilizes the "calls for service" model in determining an appropriate number of field personnel."

In FY 2013-2014, PACC has received 32,447 calls for enforcement service. During that same period, the 29 field enforcement staff officers were able to respond to only 28,834 of those calls. Therefore, the type, priority and complexity of the calls being handled allow an officer to respond to 994 calls per year. For enforcement staff to respond to the demand for service, enforcement staff would need to be increased to at least 33 officers.

- Tabled the Disabled Community representative selection.

Staff contacted the remaining candidate, Ms. Helen Mendelsohn,. She stated she had an emergency and was unable to attend. She is still willing to serve on the committee. Staff recommends the item be placed on the July 17, 2014 agenda.

Additionally, with the addition of several new members to the Committee over the last couple of years and the Committee, to the best of my knowledge, never having received an orientation on how to conduct a public meeting, I recommend the Committee invite an expert on Roberts Rules of Order and other parliamentary procedures. There is a professional organization of such parliamentarians with a local chapter here in Southern Arizona which offers such training. Please let me know if you would like to invite an experienced practitioner and a Professional Registered Parliamentarian to a future meeting to provide such a presentation.

On 05/20/14 at 17:19 hours Pima Animal Care Center dispatch operators received a call from an anonymous female that there was an emaciated white dog in the yard at [redacted]. The caller stated that the dog used to be of normal weight and ran around the yard but has been declining for the last two months. The caller stated that the dog is now very thin and walks very slowly in the yard.

5/20/14 1810 hours Officer Fish 1995 arrived at [redacted] and found a white male Boxer mix in the yard that was very thin. The dog had plenty of energy and was barking at him, however, the dog's ribs and hip bones were visible and it appeared that he was either not being fed properly or is suffering from a serious illness or a condition that is being left untreated. The dog had access to shelter in the form of the carport and there was a five gallon bucket with water available as well. It appeared that there was no one home and Officer Fish was unable to make it to the front door or make any further observations because the access gates were locked. Officer Fish remained parked in front of the property for 20 minutes or longer and no one came out so he posted a notice on the carport gate asking the owners to call Pima Animal Care Center and arrange a time to meet with an officer. Additionally, he photographed the dog and attached the photos to the activity.

06/12/14 14:00 hours I, Officer Foster 2042 met with Mr. Hemalindo at Pima Animal Care Center located at 4000 N Silverbell Rd in reference to a dog he brought to the animal intake department to request euthanasia. During the intake procedure the dog owner revealed to the kennel technician, L. Flynn #2049 that he had an open case and handed her the door knocker left by Officer Fish #1995 on 5/20/14. A technician in training contacted Supervisor D. Tenkate immediately after seeing the very poor condition of the dog he was requesting euthanasia services for. While waiting for Supervisor Tenkate the dog owner stated to L. Flynn that approximately two months ago the dog got into a bunch of peaches and began to vomit and has lost weight since then. Mr. [redacted] also stated to Ms. Flynn that he has been giving the dog Tylenol intermittently for two months also. Mr. [redacted] had documentation with him proving that the dog saw a vet on 4/10/14. However, his documentation shows

that he declined the treatment options provided by the attending veterinarian and took the dog home. Ms. Flynn then called Valley Animal Hospital and requested copies of Cooper's medical records be faxed to Pima Animal Care Center. The medical records provided by Valley Animal Hospital revealed that on 04/10/14 Cooper weighted 64.9 pounds. Cooper was weighed by Dr. Bonnie Lilly's treatment technicians on 06/12/14 and was found to weigh 43.1 pounds at the time of intake. Cooper has lost 21.8 pounds since 04/10/14. According to the medical records provided by Valley Animal Hospital, the owner stated that the dog had been losing weight and vomiting for approximately two weeks prior to his vet appointment on April 10th. On 04/11/14 a Valley Animal Hospital staff member contacted Mr. by phone and asked how Cooper was doing. Per medical records the owner stated that the dog's condition was greatly improved.

I observed Cooper to be of extremely poor weight. I was able to plainly see every vertebra, rib, and long bone. I was able to observe that Cooper was so emaciated that his muscles appeared to be atrophied and he did not have any visible fat on his body.

I asked Mr. for his driver's license and he presented me with his New Mexico driver's license. Based on the information I had and the fact that Mr. was unable to prove that he had obtained any veterinary treatment (beyond an office visit) for this dog I issued a citation for cruelty and a citation for neglect-no vet care. Mr. Lagunas acknowledged, signed, and accepted his citations. I provided him with his court date, time, location, and a copy of his citations. I then returned Mr. Lagunas' driver's license to him and thanked him for his cooperation.

On June 10, 2014 at 3:47PM I, Officer Rademaker 2019, responded to Park Place Mall on an assist police call for a dog in a hot car in the parking area in front of the Old Navy store. I met with TPD Officers C Mathis 52572 and R Green 51068 re: TPD case 1406100324. A red Chevrolet 4 door pickup truck had been left with windows open approximately 2 inches in the full sun. UA website temperature was 3:33 PM when the call was received by Pima Animal Care Center (PACC) dispatch was 105F. The Officers advised me that they had removed 2 puppies from the truck prior to my arrival as they were panting heavily and appeared to be in distress. The Officers stated that there was no water available for the puppies inside the truck. The dogs were put in an air-conditioned TPD vehicle to recover.

I photographed the red pickup and took temperature readings of the inside surfaces, which ranged from 116F to 133F.

Owner Jesus came to the scene with two children and 3 puppies, obvious siblings of the puppies that had been left in the truck. He was informed by the TPD Officers that he had been gone an hour, which he initially denied until told his arrival was on videotape. I asked what he was doing with all the puppies and he did not answer directly but one of the children said they were trying to sell the dogs. Park Place security confirmed to TPD that Mr was asked to leave the Mall because he was trying to sell the puppies. I explained the jeopardy he had put the puppies in by leaving them unattended in the hot car.

I issued Mr citations for cruelty, neglect water and neglect ventilation. I explained the citations and court and he said he understood. The two now recovered puppies were returned to him. He was given a law brochure.

05/01/14 12:48 Officer T. Bowdon 2013 impounded Adam/Frankie A472422 at 7100 E Broadway as a stray. On 05/05/14 Adam was again brought to Pima Animal Care Center by a member of the public as a stray. Due to the dog being impounded twice in one week Supervisor Carver 1901 felt it necessary to perform a premise inspection of the owner's yard to ensure there was suitable confinement at the property. An activity was created and vet care was included on the premise inspection because the dog arrived at Pima Animal Care Center with injuries.

05/08/14 18:00 I, Officer Foster 2042 met with Travis and Shey at the Pima Animal Care Center when they arrived to redeem Adam from the shelter following his second impound that week. Travis and Shey stated that Adam had escaped from a car once and the second time due to a careless houseguest. The couple appeared to be genuinely concerned that Adam had injuries. Both claimed to be unaware of them and stated that they must have been sustained while he was missing. Mr. and Mrs. were very adamant that they would obtain medical care for Adam as soon as an appointment could be scheduled. Mrs. was very emotional and stated that she thought we, Pima Animal Care Center, would not give her dog back. I explained that PACC's concern was that the dog lives in a safe environment and that his medical problems would be addressed. The couple was informed of the need for me to conduct a premise inspection that evening and that there would be a follow-up visit scheduled for seven days later. Mr. and Mrs. Darling agreed readily and stated that they would be going straight home and would be waiting for me to arrive.

05/08/14 18:50 I, Officer Foster 2042 arrived and was met in the driveway by Travis | . Mr. allowed me to enter the back yard where Frankie aka Adam (A472422) is confined when not inside the house. I asked Mr. if he objected to me photographing the yard for my field notes. Mr. agreed and apologized that the landscaping was not completed. I stated that their yard projects had no bearing on the confinement and therefore would not be an issue. I then photographed the fencing and gates. I

found that the fencing is comprised of a 4 1/2 to five foot block wall that completely surrounds the backyard. The gates are wrought iron with steel sheet metal covering the bars. I found that the owner's story is potentially true that Frankie/Adam escaped from them but did not escape from their yard. I issued a premise inspection regarding vet care for Frankie's front leg and facial injuries. I informed Mr. [redacted] that if he faxes the vet paperwork regarding Frankie's injuries following his appointment to PACC that we will not need to follow-up on the call on 5/15/14.

06/01/14 Approximately 07:30 I, Officer Foster 2042 was contacted via Pima County phone line #5902 by Michelle Kleckner of the Humane Society of Southern Arizona's Animal Cruelty Taskforce program in reference to Adam A472422. Ms. Kleckner stated that Adam is in residence at their facility and presented with a severe eye problem that, according to Ms. Kleckner requires removal per the Humane Society of Southern AZ staff vet. Ms. Kleckner stated the dog came in as a stray on 5/27/14 and the female owner called them and filed a lost report stating the dog went missing on 5/28/14. Ms. Kleckner stated that HSSAZ is investigating the situation and wishes to speak with a supervisor regarding this call.

06/06/14 10:29 I, Officer Foster 2042 arrived at 3450 N Kelvin Blvd to meet with the Humane Society of Southern AZ's Animal Cruelty Taskforce liaison Michelle Kleckner in reference to Adam a red and white Pit bull mix. Ms. Kleckner stated that Adam was brought to HSSAZ as a stray. She stated that he arrived with a severely injured eye and possibly untreated limb fractures. Ms. Kleckner stated that on 05/29/14 Shey Darling called HSSAZ and reported that Adam was missing and filed a lost report. Mrs. [redacted] stated that Adam went missing on 05/28/14 however; Ms. Kleckner stated that Adam was brought to HSSAZ on 05/27/14. Ms. Kleckner stated that the HSSAZ staff vet determined that Adam's eye required removal and subsequently performed surgery to remove it. I photographed the case information compiled by HSSAZ employees and thanked Ms. Kleckner for her time. I then relocated to the dog owner's residence.

11:08 I arrived at [redacted] and knocked on the front door. I did not immediately receive an answer. I then walked to the side door of the residence and was met by Travis [redacted] I stated the reason for my visit and asked to see proof that Adam was seen and treated as directed by a vet. Mr. [redacted] stated that his wife took Adam to the vet and he did not know where to find that documentation. I then asked if I could see a copy of Mr. [redacted] driver's license. Mr. Darling stated that his license was in Shey [redacted] possession and instead offered me a copy of his AHCCCS card. He stated that he knows his driver's license number. I wrote the license number down and asked him for his Social Security number, date of birth, height, and weight. Mr. [redacted] complied with all of those requests.

Mr. [redacted] began to tell me that he has a woman staying with him on federal probation that took off and he is dealing with that drama and that is why Adam got loose again. I stated that I would be right back and returned to the Pima Animal Care truck. I issued a citation for Cruelty and a citation for Neglect-No Vet care. When I returned to the front of the house to present Mr. [redacted] with his citations he was on the phone with Shey [redacted]. When Mr. [redacted] hung-up the phone he stated that he had trusted his wife to take care of Adam's vet care but he stated that she wasn't honest with him about it. He then stated that at first there was a holiday weekend and he and Mrs. [redacted] could not have Adam seen due to the holiday. He then stated that the dog escaped before the appointment they made. It is worth noting that Adam was to have been seen and treated by a vet prior to 05/15/14. I then stated that I was issuing citations and explained them to him. Mr. [redacted] acknowledged, signed, and accepted his citations. I then provided him with his court date, time, and location. As I was handing Mr. [redacted] his copy of the citations he stated that his wife is already thinking about obtaining another dog. I then stated that I felt that would be a bad idea recommended that the couple carefully consider the cost and responsibility of adding another pet to their home. Mr. [redacted] stated that there was no way he would be okay with her obtaining another dog. 2042



On 06/03/14 at 0946 hours Pima Animal Care Center received a call regarding a sick dog at the residence of [redacted]. The complainant advised the dispatcher that the dog potentially had parvo.

On 06/03/14 at 1015 hours I Officer Meek badge number 2015 and Officer Kirby badge number 2057 responded to [redacted] in reference to a stray sick dog complaint.

We arrived at the address and were able to make contact with a Ms. Mary [redacted]. Ms. [redacted] stated they received the dog from a friend some time back. We asked Ms. [redacted] to see the dog. We were advised her daughter was the complainant. Ms. [redacted] took us through the residence to the backyard where on a covered patio we observed a juvenile Pit Bull mix on said patio. We observed the Pit Bull to be lethargic.

I asked Ms. [redacted] how long the dog had been at the residence. Ms. Perez advised us the dog had been on the property for a while and she was unsure when her daughter brought the dog home. Ms. [redacted] then used her cellular phone and called her daughter and after a brief conversation Ms. [redacted] stated the dog had been on the property for two days. At that point I spoke with Ms. [redacted] daughter who then advised me that the dog wandered into her property the previous evening (06/02) through an open gate.

During our time spent in the yard we both observed the back gate of the property to be a solid steel gate that was barricaded on both sides keeping it shut. The back gate was photographed. In addition to the back gate there was a small walk-in gate on the north end of the residence that was also barricaded on both side with garbage cans and a brick. The walk in gate was also photographed. Inside the yard was a medium sized pile of animal waste that was freshly raked, additionally the whole yard appeared to be raked earlier that day as rake impressions still appeared to be fresh. The waste appeared to be from a medium sized dog and appeared to be old as it was dried. Upon our arrival Ms. [redacted] stated she had two small breed dogs a Chiweenie and another unknown mix breed. The waste was photographed.

We asked Ms. [redacted] again how long she had the dog and she again advised us it came in last night (06/01) and when asked about the waste she had no comment. We then asked for Ms. [redacted] identification which she provided.

We then issued Ms. _____ a citation for neglect vet care. I advised Ms. _____ that with the citation she would need to appear in court and provided with the date. Ms. _____ stated she understood her need to appear and signed her copy of the citation.

We then transported the dog back to PACC and placed the dog on the to do list to be evaluated by the treatment technician indicating a criminal citation was issued to the dog owner.



On 06/01/14 at 1134 Officer Meek 2015 responded to _____ to assist Tucson Police Department with the impound of several dogs living in poor conditions as a result of the owner being institutionalized.

Officer Meek arrived and met with TPD Officer Rodriguez badge 53760 who also provided the case number of 1406010220. Officer Rodriguez advised him that the dog owner was committed due to a mental breakdown before his arrival. Officer Rodriguez advised him there were 8 dogs on the property that did have access to the physical residence. Officer Rodriguez advised him that she had no idea how long the dog owner would be held but advised him it would be at least 72 hours and that she had no one to care for the dogs during that time.

Officers Meek and Rodriguez began to walk around the yard. Officer Meek was able to find one water receptacle that was full of garbage, rendering it non-potable. Additionally, the available water would not have lasted 72 hours with eight dogs utilizing it. He then photographed the water container. Officer Meek was able to find the location where the dogs were being fed. He observed there to be a large amount of dog kibble thrown on the ground in addition there was a malfunctioning drip system that had soaked some of the food rendering it moldy and inedible. He then photographed the food. The Officers finished walking the yard and found no other receptacles for food or water.

Officers Meek and Rodriguez made their way into the interior of the residence. They found it to have a large amount of human debris inside and found that the dogs were coming and going as they pleased. Officer Meek walked through the residence and photographed each room and the disarray they were in. The floor of the residence was saturated with a combination of urine and mud which made it difficult to walk on.

Officer Meek then impounded all of the dogs and posted a notice on the front door advising the dog owner(s) of the impoundment. All of the dogs did appear to be in good condition but Officer Meek did verbally check in with the treatment technician and advised them of his findings and the condition of the

house in case any tests were ordered by the attending veterinarian.

06/05/14 18:50 I, Officer Foster 2042 met with the owners of the animals impounded by Officer Meek on 06/01/14 at . Ms. did not have a photo identification with her when I met with them, but her partner Mr. Walter came with his Arizona State Identification card and I issued eight citations for Neglect-No Water to him for each animal on the property the day Officer Meek impounded the dogs. Mr. McGee acknowledged, signed, and accepted his citations. I provided him with his court date, time, and location. I then returned Mr. identification card to him and thanked him for his cooperation.



On 06/16/14 at approximately 12:31 hours I, PACC Officer Bowdon #2013, arrived at and observed two dogs at large roaming the property. I met with Catherine who stated that the dogs and property belong to her son and daughter-in-law, John and Raeann I advised that a report had been made of a dog on a tangled tie-out. Ms. stated she had already untangled the dog. I then observed that there was a juvenile Pitbull mix and two pups approximately 6 weeks of age in a confined area behind the house.

Ms. contacted Raeann by telephone and I spoke to her briefly about the animals. I asked her some questions about the dogs regarding length of ownership and rabies vaccination. Raeann became angry, called me a fucking bitch, and told me to get off her property and the call was then disconnected.

I resumed my conversation with Ms. Catherine I noticed that there was a Pitbull on a chain tie-out and, upon closer inspection, I observed that there was a bucket containing very dirty water. Ms. agreed to remove the dog, Deuce, from the tie-out and take the dog into the house along with all of the other dogs.

Ms. then told me that Raeann was on her way home and would be there in 20 minutes. Given Raeann's disposition on the telephone, I requested assistance from PCSO to keep the peace when Raeann arrived. PCSO Deputy Gallo #449 arrived shortly before Raeann arrived with her sister, Christie

Ms. took responsibility for the juvenile Pitbull mix, Brenda, and stated that she has been keeping her dog at her sister's residence due to being unable to keep her dog at her apartment. Ms. accepted citations for No License and No Rabies Vaccination.



On 06/19/14 at approximately 12:02 hours the Pima Animal Care Center (PACC) received a report of a female Pit Bull mix appearing to have severe injuries located at _____ Drive in the City of Tucson.

On 06/23/14 at approximately 08:43 hours PACC Officer Delgadillo #2047 and I, PACC Officer Bowdon #2013, arrived at _____ and observed a tan male Pit Bull mix of normal appearance and a white and tan female Pit Bull mix with open sores and visible scars covering large portions of her mid-section, limbs, and snout.

A woman opened the front door of the residence and identified herself as Angie _____ the owner of the dogs, Rudolph (7y) and Sugar (10y). I explained to Ms. _____ that a welfare report had been received regarding a dog matching the description of Sugar.

Ms. _____ stated that Sugar's skin had this condition her whole life and it was nothing to be concerned about. She reported that that Sugars skin has this sort of reaction every summer and that, although this has looked worse than ever lately, she continues to provide care for Sugar at home. Ms. _____ stated that she took Sugar to a vet for the condition when Sugar was still a puppy, but declined the diagnostic tests suggested by the vet. She did not recall the name of the vet.

Ms. _____ showed me a vial of an antibiotic ointment and an oral antibiotic she treats Sugar's condition with. Ms. _____ explained that the oral antibiotic had been prescribed to her husband who no longer needed them. I observed that there were 11 of 30 pills remaining in a container labeled as Cephalexin 500mg prescribed to Ezequiel _____ dated 06/16/14.

Ms. _____ did not a current dog license or proof of current rabies vaccination for either dog.

I took a photograph of Sugar and electronically sent it to PACC veterinarian Dr. Bonnie Lily. I then spoke to Dr. Lily via telephone regarding the appearance of Sugar. Dr. Lily stated that it was her opinion that the ulcerations on Sugar's body are most likely painful and that the failure to obtain vet care for the condition constitutes neglect. Dr. Lily also stated that if the condition is worsened by the sun, then Sugar should be protected from the sun.

Ms. [redacted] accepted citations for No License and No Rabies Vaccination for Rudolph and Sugar in addition to a citation for Neglect of Vet Care for Sugar. Ms. [redacted] signed a premise inspection agreement to seek vet care within 3 days or be subject to additional citations.

Later on 06/23/14 at approximately 14:15 hours, Ms. [redacted] husband came into PACC to submit paperwork from Santa Cruz Vet citing severe solar dermatitis, suspect cancerous tumor actively bleeding : left thorax 10-12 cm diam x 6cm. Mr. [redacted] said that a decision had been made to euthanize Sugar and he presented a copy of a receipt for euthanasia from Santa Cruz Vet dated 06/23/14.

On June 26, 2014 at approximately 11:10 hours I met with Tucson Police Officer Smith #100046 in reference to a dog in distress. The dog, a tan and white colored Pit Bull named Killian, had already been removed from the property and was inside the patrol car. Killian had a very large growth on her underside. When I questioned the dog's owner, Andrea [redacted], about vet care she told me that she had brought the dog to a vet about ten years ago when she noticed a small growth that she thought was a result of the surgery when Killian was spayed. She said the Veterinarian told her it was a fatty growth and was not painful for the dog so she was not concerned about it. I asked how long ago that was and she said "about ten years." I then asked if she had taken the dog to the vet again since and she told me that she had, each time the dog needed a rabies vaccination for her dog license. She told me the Veterinarian told her the growth needed to be removed but she said she could not afford the cost of the surgery and since the dog was not in any pain, she wasn't worried about it.

Outside of the home on the east side of the property was what I would guess at being two to three years of animal waste. The dogs water container and shelter were also located in this area so the dog would have to walk through the waste to get to her water and shelter. I asked Ms. [redacted] if she would clean the waste before I completed my report and if so, I would not issue a citation for the excessive waste. She refused and said she will clean it but not while I wait. I took photos of the excessive waste and of the dog.

I issued citations for failure to provide vet care and excessive animal waste. Ms. [redacted] signed the citations and accepted her copies. She also signed a release of ownership document for Killian. I then advised her of her court date and time.

On March 2, 2014 at 7:15 PM Officer Meek 2015 responded to assist Tucson Police Department (TPD) with a dog on dog attack complaint.

He arrived at the address and was able to meet with Officer Martinez badge number 49568 who also provided the case number of 1403020402. Officer Martinez advised Officer Meek that the dogs residing at [redacted] were able to break through the fence and attack the dogs at [redacted]. Officer Martinez stated that a neighborhood resident was able to dump water on the dogs to separate them and to stop the fight. When he arrived one of the attacking dogs was cornered on the side of the residence. He was able to impound the dog.

After impounding the dog Officer Meek was able to meet with the victim dog's owner, Mr. Josue Zuniga. He asked to see Mr. Zuniga's dogs and he showed Officer Meek to the back of the residence where he had the dogs confined to a restroom.

Officer Meek was able to meet with first dog, a Chow type mix named Koda. He observed Koda to have a few puncture wounds on her legs as well as several on her head and ear. She appeared to be in a certain amount of discomfort as she shook her head. He was able to photograph Koda. The next dog Officer Meek met was a Shepherd mix type named Russia; Russia did not have near the amount of punctures that Koda did but did have some on her legs. He photographed Russia.

Officer Meek asked Mr. Zuniga if he would like citations issued to the dog owner. He advised Officer Meek that he would like citations issued as well as a dangerous dog evaluation performed. Officer Meek advised Mr. Zuniga that he would indicated that information to the complaint and Officer Meek asked if the owner planned on taking the dogs to an emergency vet that evening. Mr. Zuniga advised him that the bleeding did stop and he was going to clean the dogs up to get a better view of what injuries they sustained and that he thought he would take them in tomorrow (03/03).

Officer Meek then posted a notice on [redacted] advising the dog owner of the impound of one dog. The complainant lists two dogs at that residence but neither TPD Officers nor Officer Meek were able to locate the other dog.

On March 4, 2014 at approximately 4:00PM I, Officer Rademaker 2019, met with dog owner Jose Galvez of [redacted] at Pima Animal Care Center (PACC). Mr Galvez is a self described paranoid schizophrenic who says he is under long term treatment at the VA and also has post traumatic stress disorder, bi-polar disorder and several other illnesses.

I issued him citations on behalf of Officer Meek 2015 for the incident of 03/02/14. I issued him one leash law violation citation and two biting animal citations. I explained the citations and Mr. Galvez said he understood.

I told him we would not release his dog Sadie until an officer conducts a premises inspection for confinement. I said I would do so March 5, 2014.

On March 5, 2014 at 4:19PM I went to meet with Mr. Galvez at [redacted] and found out he had gone to PACC looking for me as I arrived later than I said I would. Supervisor Montano was meeting with him and had him return to meet with me.

While waiting for Mr. Galvez I met the complainant Mr. Zuniga. He showed me where the incident took place. He said several neighbors saw the incident and would testify that both of Mr Galvez dogs were in his yard and he would like leash law citations for that dog as well. I spoke with the neighbor from [redacted] who told me he had only seen the dog Sadie in Mr. Zuniga's yard. Mr. Zuniga did not have names or addresses for the other witnesses but said the young lady who lives directly across the street to the north, her mother who lives across the street to the east in the north most apartment and the lady who lives across the street to the east in the house with lion statues. I wasn't able to contact any of them.

Mr Galvez returned home and I inspected his yard. It seems adequate repairs have been made to allow the hold to be removed for Sadie, which I noted on her kennel card.

On February 28 , 2014 at approximately 0821 hours the Pima County Animal Care Centers Dispatch Office received a bite report from the victim.

On March 11, 2014 1147 hours, Officer Bowden #2013 attempted to make contact with victim but found no one home and when she patrolled area she could not locate the described owners house or dog.

On March 27, 2014 at 1634 hours I, Officer Windauer #1984 met with victim, Elizabeth Escuvero and her mother and siblings. I was told, on February 28, 2014 at approximately 0745 hours, she had been walking eastbound on the southside of after dropping off her little sister at school. She said she saw a german shepherd dog in front yard of a pink house with the gate open. She saw a gray truck coming out of the gate. She said the driver of the truck saw the shepherd run up to her barking and then bite her leg but they did nothing. She said they put the dog back in the yard, closed the gate and then drove away.

Elizabeth said she had been wearing pants that day and hadn't realized the skin had been broken until she got home. She then called her mother who advised her to call Pima Animal Care.

I asked to see the bite wound . I saw a slight scar on the back of her upper right thigh, that appeared it might be an upper and a lower abrasion. Elizabeth advised she did not go for medical care but was upset that the driver didn't do anything or say anything to her. She requested citations be written for the incident. I was also told she had not seen the dog loose before or since, just the dog running the fence line.

I was given directions to owners house-go west on from next cross street to west . The pink house should be 3-4 properties down on southside of road-a violet house.

I located owners a few properties west of what was told me but the house was a pinkish/purpleish stucco, maybe mauve and the dog inside the yard matched the description given. On June 13, 2014 at 5:43AM Pima Animal Care Center (PACC) dispatch received a call from Howard Daberry saying that on Monday the 25th of May he was walking with dog at Udall Park when a dog got away from its owner and attacked his dog. He stated he took his dog to Monument East Veterinary Hospital for treatment (spleen was enlarged). He said he was at the park and will call back with the attacking dog owners information.

On June 13, 2014 at 7:02AM PACC dispatch received a call back from Mr. Daberry with the attacking dog owners address (). He stated that the attack happened on the 3rd of June, not May 26th. He also stated that the dog that attacked his was involved in another case, A13-119967.

On June 17, 2014 at 6:35PM I, Officer Rademaker 2019, met with complainant Howard Daberry. He said that on the morning of June 3, 2014 at approximately 6:15AM he and his wife Dorthy were walking their 2 dogs, Heeler Sienna and miniature Schnauzer Sydney, on leash at in the City of Tucson. They were on the sidewalk near the parking off between the two restrooms when a Heeler dog broke away from its owner and attack the dog Sydney, which Mr Daberry was walking. The owners of the attacking dog had been speaking with a park employee, probably named , who witnessed the attack and helped get the attacking dog off Sydney. The owner of the attacking dog did not give Mr Daberry any information at the time.

Mr Daberry spoke with another person, Nancy Whittaker, who frequently walks her dog at . He said she told him the attacking dog's owners reside at and where involved in a similar attack on her dog A13-119967. No citations were issued for this activity.

Mr Daberry said Sydney had no punctures but became ill the next day with what the vet described as consistent with trauma. Mr Daberry requests that citations be issued the attacking dog owners on his behalf for leash law and biting animal violations, that a dangerous dog evaluation be conducted and the court order restitution for his Veterinary expenses.

On June 19, 2019 at 3:15PM I went to _____ and met with owners Harry and Dorthy Wilhelmsen and interacted with their Heeler dog Freckles. The dog was friendly with me and doesn't appear to be human aggressive. I informed the owners of the complaint and they acknowledged the incident. Mr Wilhelmsen said that he never lost hold of the leash as he had it wrapped around his hand. He did admit that he did not hear the victim approaching from his back side and that Freckles did run around him, pulling the leash and making contact with the victim dog. He did agree that the park maintenance worker he was speaking with at the time, _____ did take the leash away from him and did retrieve Freckles. The Wilhelmsens seemed to have a hard time understanding how they could be cited for "biting animal" when there was no bite involved. I told them at least 5 times that the biting animal ordinance includes attack and injury being caused, even if no puncture is present.

I explained that the victims requested a dangerous dog evaluation and that the court order restitution for their veterinary expenses. I told them an Investigator would be contacting them.

I issued Mr. Wilhelmsen citations for leash law and biting animal (dog on dog attack) violations, explained court and they both said they understood.

On June 20, 2014 I went to _____ and met with _____ or _____ who said _____ works Sunday through Thursday 0600-1430. I will interview him next week and send the court an addendum to my report.

On April 24th, 2014 at approximately 15:45 hours I, Officer M. Fish #1995, responded to an emergency complaint regarding a violation dog bite with the biter reported to be still running loose in the F at . When I arrived on scene I met with the 5 year old victim, , and her mother, Carmen Ruis at their home as well as some other small children that were walking with the victim when the bite occurred. According to the victim and the other children with her they were walking in the mobile home park past at approximately 14:45 hours when they saw the black and gray dog that lives at unconfined and unattended in the street. The dog began barking and growling at the children and most them ran off, however, the victim was scared and froze in place. The dog approached the victim and according to the victim bit her on the right knee causing a small puncture wound that cause a break in the skin which began bleeding. The victim and the other kids then ran home and informed the victim's parents about the bite. When I asked if the dog owner had seen the incident or if they had told the dog owner what had happened they stated that they were to scared to try and see if anyone was home so the owner was not aware of the bite.

I was worried that the dog might still be loose and a danger to anyone else walking in the area so I followed the victim's father in my vehicle and he showed me where the dog lived. Upon seeing I realized that just a month or so ago I had been patrolling the for a Pit Bull that had been charging residents and acting aggressively and I found the dog from running loose by his home. At that time the dog had been frightened of me and was very timid but it did match the description of what the victim and the other children had described as the biter. I did not see the dog running loose at the time so I followed the victim's father back to their residence.

I photographed the victim's wounds and explained that the bite was a violation bite. I explained the quarantine process to the family and asked the victim's parents if they wished to have citations issued on their behalf for the dog bite and restitution for any medical bills that they may incur if there was a positive identification of the biter. The victim's mother did wish to have

citations issued to the dog owners. I then went to the alleged dog owner's residence and made contact with Jesus R. Velazquez and informed him of the incident that had occurred about an hour and a half earlier. Mr. Velazquez did admit that his dog, Pinto, a black and gray Heeler mix did escape from their yard at times. I related the story of my run in with Pinto a month earlier and that I had seen him loose before. I photographed Pinto and confirmed that he did in fact have a current Rabies vaccination (IMRAB 3 / Exp: 10-02-14) and was currently licensed in Pima County (L13-210586 / Exp: 10-02-14). I then returned to the victim's residence and showed the photograph of Pinto to the victim and some of the kids who were with the victim and the victim and the kids all confirmed that Pinto was the biter. I informed the victim's mother that the dog did have a current Rabies vaccination and was currently licensed in Pima County.

After receiving the positive identification of Pinto as the biter I returned to the dog owners' residence and informed them that the victim did positively identify Pinto as the dog that bit her. I explained the quarantine requirements in Pima County for violation dog bites and explained that they would need to either have Pinto quarantined at Pima Animal Care Center or at a veterinarian of their choice for the mandatory 10 day quarantine. The dog owners wanted to see what the cost differences were for quarantining their dog at our facility versus a veterinarian's office so I granted them a 24 hour quarantine transportation agreement that gave them until 17:00 hours on April 25th, 2014 to have their dog either at Pima Animal Care Center or at a veterinarian's office that can board Pinto and provide a veterinarian to monitor his health for the entire quarantine period. After explaining the quarantine process I issued Mr. Velazquez the citations for Biting Animal and Leash Law on behalf of the victim and her parents.



As he was walking past a vehicle approached and Dillon

At 1521 hours I, Officer Carver #1901 responded to the victim's address at
where I met with Pima County Deputy Borquez # 5835. Deputy Borquez related the
above incident to me and introduced me to the victim's step-father John Fugate who
confirmed the incident also. Dillon was being treated by paramedics at that time and
transported to North West Hospital. Mr. Fugate stated that they want citations issued to the
dog owner for the incident they also request restitution for all expenses related to the
incident.

I then responded to where I met with Mr. and Mrs. Robert Ballou. I
informed them of the incident. They were both surprised and concerned for Dillon and
asked if he was going to be ok. They provided me with current rabies vaccination
information for their dog Tippy. Tippy is a tan and white Sharpei mix. The vaccination was
given in September of 2013. I issued citations to Mr. Ballou for biting dog, leash law and no
current license. I placed the dog under home quarantine with the agreement that the dog
would be kept in their enclosed kennel run when the dog is outside.

At Mr. Ballou's request I returned to the victim's address and expressed his concern and
gave Mr. Fugate all of Mr. Ballou's contact information.
