JUDGING CRITERIA:

The submitted art work will be judged on its creativity, originality, visual impact and communication of the effect graffiti has on our community.

CONTEST RULES:

All participants must be 9 to 18 years old.

All artwork must be no larger than 8 ½ by 11.

One entry per person.

Artwork can be realistic or abstract and must be suitable for all audiences and contain no obscenities or profanity.

Submitted artwork will not be returned.

All entries must be received by 5 p.m. Friday, May 30, 2014. Entries submitted after the deadline will not be accepted

JUDGING:

A four-member committee of Pima County staff will review all entries based on the criteria above and select one finalist from each of five age groups: 9-10, 11-12, 13-14, 15-16, and 17-18.

A three-member panel of community leaders will select the winner from the five finalists.

The winner's artwork will be the design used for Pima County's Anti-Graffiti Campaign. And the winner will receive a \$100 gift card.

The four runners-up will each receive a \$25 gift card.

A press release will be distributed announcing the winner along with the design selected, and the runners-up.

All finalists' artwork will be featured on the Pima County TAAG website. All participants will receive a certificate of recognition.
