

I respectfully submit this letter of support for the January 8th Memorial Foundation's proposal to the Pima County Bond Advisory Committee.

There are few words to describe the horrific events of January 8, 2011. We are still trying to comprehend how one person could so greatly affect our quality of life in Southern Arizona. However, we have not and will not let this kind of terror define our community. In fact, what came out of the tragedy was a renewed sense of place and a cohesive understanding that Pima County is better when we encourage civility, respect one another, and embrace the significance of historic events that shape our community.

January 8th's 'Congress On Your Corner' event hosted by Congresswoman Gabrielle Giffords embodied the spirit of civic participation in government. It was an opportunity for the public to engage directly with their government representative. For this reason, I feel that the Foundation's mission to create a memorial in a public place like El Presidio Park is exactly what our community needs to continue healing, and to promote continued public involvement in local, state and federal government.

El Presidio Park's existing environment is one of engagement. The south perimeter of the park includes Pima County's Administrative Complex, Pima County Superior Court, and the Pima County Board of Supervisors Hearing Room. The west perimeter of the park includes Tucson's City Hall and the City Council Chambers. The Eastern perimeter is home to our Historic Courthouse built in 1929, which currently includes the offices of the Pima County Recorder, Assessor, Treasurer, and Justice Courts. El Presidio Park is truly the heart of government in Pima County and the City of Tucson. It is the place for 'Congress On Your Corner' to live on.

I support the Foundation's collaborative approach at creating a public memorial honoring January 8th. The Foundation's effort to engage community in the design process is the correct approach. It is a multi-faceted endeavor that includes victims of the shooting, neighborhood representatives, historical observers of El Presidio Park, and our arts community. All these elements are necessary to memorialize a tragedy of national scope and historic importance.

The beautiful and historic Old County Courthouse is a cherished landmark and irreplaceable cultural/historic resource that deserves to play a prominent role in the Tucson community. It is essential that we allocate necessary funds to ensure its continued protection and adaptive use, including its interior and exterior spaces.

This building is a revered feature both to Tucsonans as well as visitors who pass through and appreciate its classic architecture and historic relevance. I know that when I first arrived in Tucson, this building made a great impression upon me. It is without question the most beautiful building in Tucson, and I am so thankful it has been preserved.

And so it only stands to reason that it must be protected and adaptively used---for contemporary office spaces, yes, but also for historic and artistic expression. As a former journalist, I was shocked by the events of January 8 and elevated by the response of our community to such an assault on normality in our city.

The stories of the events of that day and of the humanity shown by ordinary Tucsonans and citizen around the U.S. and the world must be given a place to be shared.

Those who don't know their history are condemned to repeat it. And those who can be inspired by a horrific act and give their most personal sense of hope to the victims, their families and all who shared in our collective grief deserve to have a place of honor and reflection in our midst.

This was more than a national tragedy. It was a moment of strength and collective will on the part of our community, which proved larger and more compassionate than we could ever have imagined.

More than that, a permanent memorial can act as a place of simple truth where the reflections of the survivors and responders on the events of that day, its effects on their lives and its importance for discourse on America's future can be made available without media hype or sensationalism. The experiences of these people have power and need to be shared in a place that also contains the physical relics of that emotional time.

It will be a place that will bring people together in our community and invite others from around the world to share in the experience of that time in a meaningful and healing way. I urge you to support its inclusion in the pending bond package.







> On January 8, 2011, my wife and I were the couple talking with then-Congresswoman Giffords when the deranged gunman opened fire, shooting 19 persons, 6 of which either died at the scene or at the University of Arizona Medical Center. Thankfully, my wife was not shot but I was critically wounded twice in the upper right chest and in the lower right leg. According to Dr Peter Rhee, I was the next most critically wounded, aside from Congresswoman Giffords. I was very close to death when I arrived at the UAMC's Trauma Wing.

> The proposed memorial will honor the 19 individuals who were either killed or wounded while exercising their right to assemble and to exercise free speech, both of which are guaranteed by the Constitution of the United States. Our assembly was both peaceful and orderly prior to the shooting: a Democrat (Ms Giffords) and Republicans (My wife and I) participating in a civil dialog for the betterment of our city, county, state and country.
