Dear Mr. Heckler:

I am writing on behalf of PR96 "Aircraft Flying Fields" in hopes that your Bond Advisory Committee will vote in favor of its funding. PR96 is a \$1.5 million proposal that will provide monies for capital improvements for five area aircraft radio control clubs which have been safely operating RC aircraft for over 130 years. We cover Pima County from Green Valley to Avra Valley, from northwest Tucson to southeast Tucson and support a myriad of activities throughout the county.

The greater Tucson area RC Community supports youth activities, raises money for various charitable organizations, runs a safe structured flying environment, provides liability insurance, brings money into Pima County and hasn't cost the city, the county or the state one thin dime in operations and maintenance expenses. We also are the sole support for two local area businesses: Hobby Barn located on 21st Street and Hobby Town on East Speedway Blvd.

I specifically represent a consortium from Southern Arizona Modelers (SAMs), which has been operating in Pima County for over 40 continuous years, and Tucson Radio Control Club (TRCC), which has been operating for over 50 years. I have briefed Superintendent Ray Carroll on PR96 and he has wholeheartedly endorsed PR96 in general and the specific proposal put forth by SAMs and TRCC. My name is Robert Welsh, I am coach of the Tucson Royals Club Baseball Team as well as a team manager and former board member for District 12's Santa Rita Little league and I represent a couple of hundred kids that would benefit greatly from having a quality baseball facility here in the greater Tucson area.

I am writing this email to show support for the Tucson Youth Baseball Association and its quest to develop a premier youth baseball facility on the grounds of the Kino Sports Complex. Such a facility would do wonders for the youth baseball community in Southern Arizona, and create a positive impact for local businesses, families and many more. The youth baseball community is facing many problems right now that have an impact on many people.

Currently, there is a lack of field space to accommodate the number of players playing baseball at the ages of 14 and below. With the lack of field space and the increase in year-round travel baseball, families and teams are forced to travel to Phoenix and other cities outside of Tucson to play in tournaments and leagues. With beautiful year-round weather, and a strong club baseball community, Tucson has all of the ingredients to be a national level tournament destination. A premier youth baseball complex would make this happen, keeping local families and teams in Tucson, saving them thousands of dollars, while bringing in families and teams from all over the state, the country and the world, having a positive impact on local businesses year-round.

The costs of field usage for many city and county baseball fields have increased to a level that has made it very tough or impossible for many families to allow their children to play the sport of baseball. With high prices and the limited number of age-specific fields, the number of entry-level players in Southern Arizona has decreased. With the development of a youth baseball complex, that is funded by tournament usage, the price to play to play the sport for Pima County residents will lower dramatically allowing more kids to play, creating energy for baseball in the region which will result in higher participation numbers for entry level organizations such as Little League.

I have been to Phoenix countless times for tournaments and I always find my self asking why we don't have at least one quality youth baseball facility in Tucson that could be used to hold USSSA, Triple Crown and Little league All-star tourneys. I know from personal experience that the number of facilities in Phoenix allows these organizations to hold many tournaments there and in doing so, brings a steady revenue to the hotels and restaurants located in and around these parks.

Having youth sports in the development of a child is very important. Leadership, patience, work ethic, teamwork and adversity are all examples of lessons that are being taught to the youth in our community through their involvement in baseball. A facility like this would give kids and families across Southern Arizona a place for these life skills to develop, fostering a stronger bond in the community both socially and economically, but more important a place where we will see our youth develop into our community's leaders of tomorrow.

I appreciate your hard work during this important process and hope you can see how this project will benefit the young baseball players, their families and the community of Southern Arizona.

I am the Chairman of the Western Pima County Community Council. We are a liaison between our area and Pima County government. At our last board meeting, the Board voted unanimously to send you an e-mail supporting the inclusion of the Ajo Community Golf Course in the next bond election. We support the golf course in their search for funds for upkeep and improvements to the course. The course is very important to the economic health of our community. It draws in players who start out as winter visitors and tourists passing through and go on to become property owning residents providing a healthy addition to county property taxes.

The infrastructure of the course is old and in precarious condition. It is maintained on a daily basis by hard working volunteers, but if something of a more serious nature occurred, it might not be possible for the golf course to continue in operation. Freeport MacMoran (the largest corporation in Arizona) indicated its support of the golf course by the donation of a water storage tank to replace one that was in eminent danger of collapse.

Besides the golf course itself, Ajo Community Golf Course provides a restaurant and bar that is utilized by local residents during the winter season. It is one of the few large banquet areas and has hosted weddings, proms, local clubs and a Fiddle Contest on an annual basis. All of these events improve the economy of the area as they bring in out of state dollars and local dollars to circulate through the town and the county.

Please continue to include this request in the next bond election. Our request for \$320,000 is small in comparison to the total bond amount, but the need for our town is huge.

Greeting, I am writing in support of placing Ajo Community Golf Course on the Pima County 2015 Bond issue. The Ajo Community Golf Course is so very important to the economic well being of Ajo. Quite a large portion of the population is in Ajo because of the golf course. My wife and I are two such people. We moved here for retirement , bought home and remain here because of our ability to golf and enjoy a small unique community.

The golf course supports the economy of the community in many ways. RV people stop to enjoy golf, eat in the restaurant and spend several nights enjoying the lush setting in the evenings and early mornings. They explore and shop in Ajo.

We call the golf course "our gem in the desert". The restaurant is the most favoured in the community. It not only provides dinning in a unique setting but more importantly provides cook and waitresses jobs. The winter season is particularly busy with large participation in the

Annual Old Time Fiddlers for its 37th year in 2015. Large groups of local organizations use the restaurant for meetings, dinners and holiday banquets.

The golf course provides much needed youth activities with the Hooked on Golf program. Many tournaments held each winter bring participants from outside of the community. Fund raising tournaments for local needs such as the Desert Senita Health Clinic are held each winter.

The golf course is in desperate need of improvements beyond the ability to be provided by the many volunteer workers and the normal income of the golf course. The irrigation system is in constant repair, the water and electrical system requires constant repair. The Ajo Community Golf Course needs the funds from the bond issue to remain in operation. The economic impact of the closure of the golf course would be disastrous to Ajo.






