I strongly support the admission of the Ajo Golf Course on the bond proposal. This golf course and the associated Ajo Country Club are terrific assets to the community and essential for it's continued survival! Ajo has suffered long and hard since the copper mine closure decades ago. There is a strong trend for these types of towns to shrivel up and disappear as young people move out and the resident population dies off. Ajo's best hope for future and sustained economic stability lies with tourism, and especially from the "snowbird" contingent. This part of Pima County is already discovered and loved by many who enjoy the winter weather and beautiful Sonoran Desert and Organ Pipe National Park.

I have been visiting Ajo since 1992, and have many friends that live there. I can see that Ajo is on that teetering edge of success or failure. The golf course and country club are instrumental in attracting new visitors and keeping "snowbirds" and residents content to stay there! My name is Dominic Cuffel, I am a parent member of The Tucson Royals and I represent at least two hundred youth baseball players.

I am writing this email to show support for the Tucson Youth Baseball Association and its quest to develop a premier youth baseball facility on the grounds of the Kino Sports Complex. Such a facility would do wonders for the youth baseball community in Southern Arizona, and create a positive impact for local businesses, families and many more. The youth baseball community is facing many problems right now that have an impact on many people.

Currently, there is a lack of field space to accommodate the number of players playing baseball at the ages of 14 and below. With the lack of field space and the increase in year-round travel baseball, families and teams are forced to travel to Phoenix and other cities outside of Tucson to play in tournaments and leagues. With beautiful year-round weather, and a strong club baseball community, Tucson has all of the ingredients to be a national level tournament destination. A premier youth baseball complex would make this happen, keeping local families and teams in Tucson, saving them thousands of dollars, while bringing in families and teams from all over the state, the country and the world, having a positive impact on local businesses year-round.

The costs of field usage for many city and county baseball fields have increased to a level that has made it very tough or impossible for many families to allow their children to play the sport of baseball. With high prices and the limited number of age-specific fields, the number of entry-level players in Southern Arizona has decreased. With the development of a youth baseball complex, that is funded by tournament usage, the price to play to play the sport for Pima County residents will lower dramatically allowing more kids to play, creating energy for baseball in the region which will result in higher participation numbers for entry level organizations such as Little League.

Having youth sports in the development of a child is very important. Leadership, patience, work ethic, teamwork and adversity are all examples of lessons that are being taught to the youth in our community through their involvement in baseball. A facility like this would give kids and families across Southern Arizona a place for these life skills to develop, fostering a stronger bond in the community both socially and economically, but more important a place where we will see our youth develop into our community's leaders of tomorrow.

I appreciate your hard work during this important process and hope you can see how this project will benefit the young baseball players, their families and the community of Southern Arizona.





Dear Mr. Lawrence M. Hecker, Jr.:

The UA Cycling Team is a strong supporter of the Tucson Velodrome project. UA Cycling competes in a variety of cycling disciplines including road, mountain, and cyclocross. We have several current riders who, if given the chance, would race track as well. UA Cycling has recently been recognized by USA Cycling as an emerging varsity team, which means we will be compared to other varsity programs such as Ft. Lewis, Marian University, Lees McRea, and Lindenwood University to name a few. All of these varsity programs have a velodrome near their campus and use it as a recruitment tool. It would be no different for our program.

Currently, we have 76 members on our roster with 27 from out of state. Each summer we receive numerous inquiries about our program from high school seniors and having a velodrome would provide an excellent boost to our recruitment tools and bring in additional out-of-state riders. One of our goals is to establish a program which is competitive at a national level in all cycling disciplines. Unfortunately, we cannot build a track team without a velodrome- San Diego or Hermosillo are simply too far away.

Beyond assisting UA Cycling in recruitment, retention, and training, a velodrome would be a complete Tucson and Pima County's work to become a national and international cycling destination. Already hundreds of riders from across the US and Canada set up temporary residence in Tucson for the winter months. Our main competition for winter riders, Boulder, CO, just finished their velodrome. If we are to remain competitive in drawing out of state riders in, we must stay relevant and provide facilities riders want.

Furthermore, a velodrome will provide a significant economic impact over the life of the project. Studies conducted on the Rock Hill velodrome have demonstrated the project will return the public's investment plus a small rate of return. However, the more important impact is on the lifestyle and health habits of the community, especially our youth. With schools cutting PE programs, it is absolutely vital to provide exercise opportunities for area youth. A velodrome provides a safe, friendly, and welcoming environment for children to exercise, interact, and grow as individuals. Youth after school programs offer the best chance to establish healthy life long habits.

A velodrome, as you can see, offers incredible potential for the county, city, and university. Our program would be well on its way to national preeminence, the community would be forever cemented as a cycling destination, and we'd be able to provide area youth with a strong opportunity to develop healthy habits. All three of these benefits make the project a win-win; however, the fact similar sized investments in velodromes have a complete monetary return on investment makes the project a no brainer. I'm confident a velodrome in Tucson would be a fantastic success and UA Cycling would be more than willing to volunteer at the facility.

I am also confident that by showing support for the project, private donations might flow in immediately, which could be used to accelerate construction. While it may take some time for construction to start, I'm excited to see a track in the desert!
