Having lived in the Flowing Wells area for most of the last 47 years, we have experienced the continuing lack of action along Roger Road. Beyond an occasional repair to potholes. until the opening of the new Charter School in the 700W block, there has been nothing done to stabilize, upgrade, or widen the roadway. Drainage problems have already been presented to the Ruthrauff study group, however new drainage, new sidewalks, curbs, and lighting are long overdue. A simple time-based traffic signal to replace the 4-way stop at the Roger Rd and Fairview intersection would also help with pedestrian and bike traffic I support any attempts to fix Roger Rd, especially if it can involve both the City of Tucson AND Pima County working in a cooperative manner.

The roads between my house and my center city office were scary and I didn't want to figure out how to cross I-10 and the train tracks. The improvements of the past year or two -- the physical barricades, green paint, better designated bikeways, and street diets-- have changed discomfort to comfort and four months ago, I bought a bike again and am starting to integrate it into my west-side lifestyle. Some of the challenges remain but they are fewer. One of those challenges is the connectivity of streets that abruptly go from good and safe to narrow and scary. So, I very much like both the specifics and the philosophy behind

Comment this proposal -- finding places that need better connections and improving people's feelings of safety. The times that I have been able to bike to work, show me Tucson in a new way. I notice the parents and children walking to school, people waiting for the bus, the kind homeless couple who helped me navigate the trains tracks in the warehouse district, the public art of the Dunbar Spring neighborhood, and more. It helps me see the diversity and vitality of the city, and that "interestingness" is a reason (besides health and clean air) to get on my bicycle in Tucson. 


